#### REVIEW PROPOSED AMENDMENTS

2018 IMC 908.1, 918.1,  
918.2, 1101.2, 1101.6 &  
1501.3

Andrew Klein spoke to the Committee in connection with his proposed amendments. Following the review, a motion was made by Chris Jensen to approve the proposals. The motion was seconded by Terry Palmer and passed unanimously.

A motion was made by Terry Palmer to make a recommendation that the changes made to Section 1107-1110 be accepted. The motion was seconded by Chris Jensen and passed unanimously.

The Committee reviewed the remaining current amendments to the IMC and the following motions were made.

A motion was made by Chris Jensen to make a recommendation to keep the current amendment for Section 1004.2. The motion was seconded by Terry Palmer and passed unanimously.

A motion was made by Chris Jensen to make a recommendation to keep the current amendment for Section 1004.3.1. The motion was seconded by Roger Hamlet and passed unanimously.

A motion was made by Terry Palmer to make a recommendation to keep the current amendment for Section 1209.3. The motion was seconded by Chris Jensen and passed unanimously.

The Committee will start the review of the 2021 IFGC at the June meeting following further review of the tabled items.
