### **Committee Updates**

Vice President Marie Stevenson updated the Board of the events the Foundation Department is involved in. With the help of Chevron and Hogan and Associates 40 people were honored with the Best of Davis Award. On May 13, 21 Casey Bradberry from Bountiful Jr. High School was honored as Davis Teacher of the Year. Young Kia and Golden West Credit Union provided a one-year Lease and Insurance for Ms. Bradberry. On May 14, 21 the Foundation awarded two future educators from the Latino in Action program with a 4-year scholarship. Young Power up Stores in Davis County donated \$10,000.00 in cash along with a trailer full of Hygiene packages for the District Teen Center. The Foundation in partnership with the Bountiful Food Pantry donated more than 100,000 food packs to our children in the Davis School District over the course of this year. The Foundations Gala is on June 9, 2021, at the Centerville Megaplex.
