**A RESOLUTION CERTIFYING THE CANVASS OF THE
2021 SALEM CITY MUNICIPAL GENERAL ELECTION**

WHEREAS, pursuant to Utah Code Ann. § 20A-4-3014(2)(a), the Mayor and the Municipal Legislative Body constitutes the Board of Canvassers of Salem City;

WHEREAS, on November 16, 2021, the Board met to canvass the election returns of the 2021 Salem City Municipal General Election held on November 2, 2021;

WHEREAS the election returns for each voting precinct have been received and counted by the Utah County Clerk's Office; and

WHEREAS the Board publicly canvassed the returns and determined from them the vote of each voting precinct for each candidate;

NOW, THEREFORE, be it resolved by the Salem City Council, acting as the Board of Canvassers, as follows.

1. Approval of Election Results. The City Council, as the official Board of Canvassers, hereby accepts and approves the attached report entitled “Official Final Election Results – 2021 General Election” for the 2021 Salem City Municipal General Election held November 2, 2021. The following candidates are declared to have received the number of votes indicated:

2. Declaration of Election. The City Council, as the Board of Canvassers, declares “elected” the following persons to the municipal office indicated:

The City Recorder is authorized and directed to deliver a “Certificate of Election” to said candidates.

3. Certified Report of Election Results. For the purposes of Utah Code Ann. § 20A-4-304, the Certified Report of Election Results, when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- a. Record and file the certified report in a book kept for that purpose;
- b. Prepare and transmit a certificate of nomination or election under the officer's seal to each elected candidate;
- c. Publish in a newspaper of general circulation in the Board's jurisdiction, on the Utah Public Notice Website, and on the City website, a copy of the certified report or a statement that the Board of Canvassers for Salem City has prepared a report of the election results for the 2021 Municipal General Election and specify the sources where an individual may view or obtain a copy of the entire certified report; and
- d. File a copy of the certified report with the Lieutenant Governor.

4. Effective Date. This Resolution is effective immediately upon passage.




