8:30 Discussion with Possible Approval of Canvass Numbers for Election November 2, 2021 – Mayor Lori Nay

Mayor Nay brought the meeting to order and turned the time over to City Recorder Steven Jenson to explain the reason for the meeting. City Recorder Steven Jenson responded that the special meeting had been called because Sanpete County had the canvass numbers for the election that happened on November 2, 2021, and they needed to be signed off by the Council and the Mayor by 11/16/2021, and the next City Council Meeting was scheduled for 11/17/2021. Steven Jenson then went over the breakdown of the numbers and the winners. Mayor Lori Nay, Councilmember Robert Andersen, and Councilmember Shawn Crane had run unopposed and had won another 4-year term. Councilmember Michael Wanner had run against candidate Jay Clayton and received 279 votes to 85. Councilmember Michael Wanner would serve for 2 years until his term was up.

There were 959 active registered voters, and the turnout election night was 368 voters, or 38.37% The final turnout was 370 or 38.58%. Two Ballots were received after election day. No provisional ballots were submitted. One ballot was not counted, and one ballot was returned with a signature that did not match signature on voter's registration. There was some confusion with the radio on November 4, 2021, in reading out the winners. Due to the percentages next to Robert and Shawn's names it seemed that only Robert Andersen was elected.

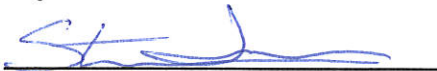
As of November 8, 2021, there were 57 votes audited per the Lieutenant Governor's Office. There were no errors found during the audit.

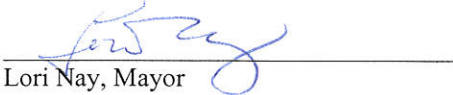

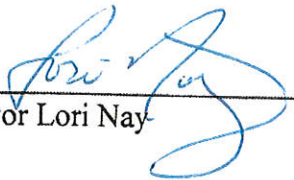

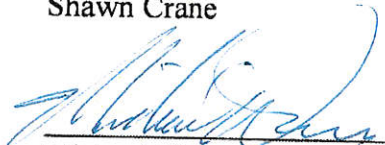
