RESOLUTION NO. 49

A RESOLUTION OF THE MUNICIPAL BUILDING AUTHORITY OF
SALT LAKE COUNTY AUTHORIZING EXECUTION OF AN
INTERLOCAL COOPERATION AGREEMENT WITH SALT LAKE
COUNTY

RECITALS

- A. The Salt Lake County (the "County") recently acquired a parcel of real property in South Salt Lake City, Utah, where the Municipal Building Authority of Salt Lake County (the "MBA") plans to build a new library (the "Granite Property").
- B. The Salt Lake County Municipal Building Authority (the "MBA") intends to finance the construction of library facilities at the Granite Property through the issuance of municipal bonds.
- C. Therefore, the County has agreed to transfer title of the Granite Property to the MBA.
- D. The Salt Lake County Library Board has approved transfer of the Granite Property to the MBA.
- E. In furtherance of the above stated public purpose, the County and the MBA have negotiated an Interlocal Cooperation Agreement that contains the terms and conditions governing the transfer.
- F. It has been determined that the best interests of the MBA and the general public will be served by entering into the Interlocal Cooperation Agreement. The execution of said Interlocal Cooperation Agreement will comply with all applicable state statutes and County ordinances.

NOW, THEREFORE, the Governing Board of the Municipal Building Authority of Salt Lake County resolves that the Interlocal Cooperation Agreement between the County and the MBA is hereby approved, and that the President is authorized to execute said Interlocal Cooperation Agreement and any additional documents necessary to effectuate the transfer of the Granite Property to the MBA.
