COMMISSIONER LEE – JUST FOR NOTE, WHEN I CAME IN AS COMMISSIONER AND THE LAW HAS NOT CHANGED SINCE I CAME IN, WE NEVER PUT ANY BACKUP DOCUMENTS ON OUR AGENDAS AND WE WENT THROUGH THIS PROCESS AND AS YOU SAW DURING OUR PROCESS THAT OFTEN WE WILL MODIFY AND CHANGE DOCUMENTS WHICH DOESN'T NECESSARILY TRIGGER THAT WE GO TO ANOTHER COMMISSION MEETINGS JUST BECAUSE OF THAT CHANGE/MODIFICATION OF DOCUMENTS. WE PUT THESE DOCUMENTS ON HERE AS MUCH AS POSSIBLE UNLESS THEY'RE PROTECTED FOR SOME REASON OR ANOTHER, OUT OF COURTESY TO THE CITIZENS AND TO EVERYONE SO THAT THEY CAN SEE THEM ON A TRANSPARENCY BASIS. NEVERTHELESS, THERE WAS SOME QUESTIONS RAISED ABOUT THERE NOT BEING DOCUMENTS IN THE FULL 24-HOUR NOTICE BEFOREHAND. IF THERE'S SOME PUBLIC CONCERN, I'D SURE LOVE TO HEAR IT IF THEY WOULD LIKE TO TALK AS WELL AS THE COMMISSIONERS.

COMMISSIONER GARDNER - AND JOSH (DANIELS, COUNTY CLERK/AUDITOR) MAYBE YOU COULD GIVE US AN OVERVIEW OF THIS PROCESS AND WHY THE TIMING IS THE WAY IT IS.

JOSH DANIELS, COUNTY CLERK/AUDITOR – THE UNITED STATES CENSUS BUREAU DID NOT DELIVER THE REQUIRED CENSUS DATA FOR REDISTRICTING UNTIL 6 MONTHS AFTER THEIR TYPICAL TIMELINE SO STATES ALL ACROSS THE COUNTY HAD TO TURN AROUND REDISTRICTING PROCESSES TO REDRAW LOCAL AND STATEWIDE AND FEDERAL DISTRICTS AND NOW LOCAL PRECINCTS ON A MUCHABBREVIATED TIMELINE. WE HAD A LOT OF PEOPLE IN OUR OFFICE AND KRISTEN SWENSON LED THEM ALL TO GET THESE PRECINCT BOUNDARIES DRAWN ON A VERY, VERY ABBREVIATED TIMELINE. THE CODE REQUIRES YOU TO ADOPT PRECINCTS, IF YOU'RE GOING TO MAKE CHANGES, BY THE END OF THE YEAR. WITH REDISTRICTING, YOU CAN GET A LITTLE BIT OF EXTRA TIME IF YOU NEED IT BUT THE REASON IT'S IMPORTANT THAT WE GET THESE DISTRICTS OUT

IS SO THAT POLITICAL PARTIES AND OTHERS ARE ABLE TO KNOW WHAT THOSE BOUNDARIES LOOK LIKE, BUT I THINK IT'S IMPORTANT THAT YOU MOVE FORWARD WITH THESE RIGHT NOW.

COMMISSIONERS AND JOSH DANIELS DISCUSS PRECINCTS INCREASES, CODE, MUNICIPAL BOUNDARIES, SCHOOL DISTRICTS, VOTER PARTICIPATION AREAS, POPULATION GROWTH, HOUSE AND SENATE SEATS, ETC.

COMMISSIONER LEE – COULD WE WAIT A WEEK TO APPROVE TO GIVE THE PUBLIC A CHANCE TO LOOK AT THIS INFORMATION?

JOSH DANIELS – I DON'T THINK ANYTHING MATERIALLY WOULD CHANGE BECAUSE THE PRECINCTS MAKE A LOT OF SENSE. SOONER THAN LATER IS BETTER BECAUSE IN THIS EVENT, THE NEXT STEP IN JANUARY, YOU'LL START TO HAVE CANDIDATES WHO WILL WANT TO START PETITIONING FOR SIGNATURES FOR RUNNING FOR OFFICE.
