#### 5. Reports

#### a. Administrative Report

Jonathan Seal, Director of Operations, provided an update on the current state of the school, including increasing enrollment. The school is gearing up for testing and then second semester will begin.

#### 6. School LAND Trust Council

#### a. Training

Elisse Newey, the USBE School LAND Trust Program Administrator, provided board training on the School LAND Trust program. She introduced the members of the School LAND Trust team and individual roles. Training covered the purpose of the program, where funding originates, and the process to develop annual plans.

#### a. Finance Report

Travis Jones reported on the status of the audit, which is almost complete with no anticipated findings. The financial reports were provided, and the school is on track for this point in the school year. The school has a healthy savings and days cash on hand. The federal funds are reimbursable and have not yet been received.

#### 8. Voting Items

#### a. Policy 0418. Dual Enrollment and Split Enrollment

Platte Nielson reviewed the proposed amendments to the policy which are meant to clarify the difference between dual enrollment and split enrollment and to explain that the school doesn't permit dual enrollment but does permit split enrollment under certain conditions. The proposed amendments rename the policy the "Dual Enrollment and Split Enrollment" policy, simplify the school's split enrollment rules, and refer to the Utah Code and Administrative Code Rules with respect to how the school will handle extracurricular and co-curricular activities. The ability for students to participate in other entities activities was discussed.
