1. PURPOSE AND PHILOSOPHY

- 1.1. The Utah Constitution requires that public elementary and secondary schools be free, except that the legislature may authorize the imposition of fees in secondary schools. The Utah Legislature has authorized fees in secondary schools and, along with the Utah State Board of Education, imposed various permissions, restrictions, and requirements related to student fees. This policy is adopted to comply with the law and create a fee system aimed at balancing increased student access to educational opportunities with the incremental burden of school fees
- 1.2. Utah law requires that the imposition of any fee in public elementary or secondary schools be authorized by the local school board. Therefore, all fees assessed by Nebo School District schools or employees must first be approved by the Board of Education and listed on the applicable fee schedule. This policy and the attached fee schedules are adopted to authorize the fees listed on the fee schedules and to ensure that only fees authorized by the Board are charged to students.
- **1.3.** This policy is further designed to provide adequate notice to students and families of fees, fee waiver availability, and fee waiver requirements; to limit student expenditures; and to provide guidance and procedures regarding fees imposed upon students in the District.

2. DEFINITION OF FEE

- **2.1.** "Fee" means a charge, expense, deposit, rental, or payment:
 - **2.1.1.** regardless of how the charge, expense, deposit, rental, or payment is termed, described, requested, or required directly or indirectly;
 - **2.1.2.** in the form of money, goods, or services; and
 - **2.1.3.** that is requested or required as a condition to a student's full participation in an activity, course, or program that is provided, sponsored, or supported by the District or its schools.

- 2.2. "Fee" includes:
 - **2.2.1.** something of monetary value that is impliedly or explicitly mandated or necessary for a student, parent, or family to provide so that a student may
 - **2.2.1.1.** fully participate in school or in a school activity, class or program;
 - 2.2.1.2. successfully complete a school class for the highest grade; or
 - **2.2.1.3.** avoid a direct or indirect limitation on full participation in a school activity, class, or program, including limitations created by
 - 2.2.1.3.1. peer pressure, shaming, stigmatizing, bullying, or the like; or
 - **2.2.1.3.2.** withholding or curtailing any privilege that is otherwise provided to any other student;
 - **2.2.2.** money or something of monetary value raised by a student or the student's family through fundraising;
 - **2.2.3.** charges or expenditures for a school field trip or activity trip, including related transportation, food, lodging, and admission charges;
 - **2.2.4.** payments made to a third party that provides a part of a school activity, class, or program;
 - 2.2.5. charges or expenditures for classroom:
 - 2.2.5.1. textbooks;
 - 2.2.5.2. supplies; or
 - 2.2.5.3. materials;
 - 2.2.6. charges or expenditures for school activity clothing; and
 - **2.2.7.** a fine other than a fine described in Subsection 2.3.2.
- 2.3. "Fee" does not include:
 - **2.3.1.** a non-waivable charge as described in Section 3
 - **2.3.2.** a student fine for:
 - 2.3.2.1. failing to return school property;
 - **2.3.2.2.** losing, wasting, or damaging private or school property through intentional, careless, or irresponsible behavior, or as described in UTAH CODE ANN. § 53G-8-212; or
 - **2.3.2.3.** improper use of school property, including a parking violation;
 - 2.3.3. a payment for school breakfast or lunch;
 - 2.3.4. a deposit that is:
 - 2.3.4.1. a pledge securing the return of school property; and
 - **2.3.4.2.** refunded upon the return of the school property; or

2.3.5. a charge for insurance, unless the insurance is required for a student to participate in an activity, course, or program.

3. NON-WAIVABLE CHARGES

Consistent with the definition of a fee in Section 2, and especially the description in paragraph 2.3 of charges that are not fees, the following are descriptions of non-waivable charges that do not constitute fees subject to waivers or other restrictions set forth by this policy.

- 3.1. A personal discretionary charge or purchase, including
 - **3.1.1.** A charge for insurance, including a mobile device protection plan, unless the insurance is required for a student to participate in an activity, class, or program;
 - **3.1.2.** A charge for college credit related to the successful completion of a concurrent enrollment class or an advanced placement examination; and
 - **3.1.3.** Except when requested or required by the District, a charge for a personal consumable item such as a student picture, yearbook, class ring, graduation announcement, letterman jacket or sweater, or similar item. Schools may also offer parents/guardians the convenience of purchasing physical education clothing at a reasonable cost through the school. The cost of such clothing shall not be considered a fee unless the particular style, color, or brand of clothing is required by the school.
- **3.2.** A charge for replacement or repair of items lost or damaged by a student.
- 3.3. Project-related courses must be based upon projects and experiences that are free to all students. Students may be allowed to choose optional projects for which they must provide materials, but a student may not be required to select an optional project as a condition for enrolling in or completing a course. The cost of materials for such optional projects is not considered a fee and will not be waived. However, costly optional projects should be avoided if they result in pressure by teachers or peers to construct such projects.
- 3.4. A reasonable charge may be assessed to cover the cost of duplicating student record transcripts when such transcripts are to be provided to the student or mailed to colleges, universities, or places of employment. A charge will not be assessed for transcripts which are required as part of a transfer to another public or private elementary or secondary school. These charges are not considered to be school fees.
- 3.5. Schools may assess a reasonable admission charge for optional attendance at school dances, performances, competitions, or games when those activities are not held during the school day. Secondary students are issued activity cards which allow free or reduced price admission to extra-curricular activities sponsored by their schools. Except for admission charges that are determined by the Utah High School Activities Association or by the local competitive region to which the high schools belong, a schedule of admission charges assessed in connection with extra-curricular activities must be reviewed and approved each year by the School Community Council.
- **3.6.** The optional purchase of an item available to students from a vending machine, concession stand, or school store is not a fee.
- **3.7.** A convenience charge may be assessed for credit card transactions. The convenience charge does not constitute a fee if students and parents have the option of paying by cash or check to avoid it. The convenience charge may be designated as a fixed dollar amount per transaction or as a percentage of the charged amount.
- **3.8.** Federal law permits schools to charge for food or drink provided as part of the Child Nutrition Program in both elementary and secondary schools. Parents may submit an application to the District for free or reduced price meals and milk in accordance with Nebo School District Policy EF, Child Nutrition Programs.

4. AUTHORITY TO CHARGE FEES

Under the Utah Constitution, public elementary and secondary schools are to be free, except that the legislature is permitted to authorize the imposition of fees in secondary schools. Utah law permits the charging of fees as described in this section.

4.1. Elementary Schools

- **4.1.1.** For purposes of this policy, an elementary student is a student enrolled in a school that provides instruction to students in grades kindergarten, 1, 2, 3, 4, or 5.
- **4.1.2.** Except as specifically provided in this section, Utah law prohibits the charging of fees for anything that takes place during an elementary student's regular school day, including but not limited to, textbooks, classroom equipment or supplies, field trips, and assemblies.
- **4.1.3.** Fees may be charged by elementary schools for programs offered before or after school or during school vacations. No fee may be charged to or requested of an elementary student unless the fee has first been approved by the Board and listed on the Elementary Fee Schedule.
 - **4.1.3.1.** Any such fees are subject to fee waivers under Section 6 of this policy.
 - **4.1.3.2.** Alternatives to fee waivers may not be required of elementary students.
- **4.1.4.** An elementary school or elementary school teacher may compile and provide a suggested list of supplies for use during the regular school day so that parents and guardians may furnish those on a voluntary basis. Suggested lists must be preceded by the following language:

NOTICE: THE ITEMS ON THIS LIST WILL BE USED DURING THE REGULAR SCHOOL DAY. THEY MAY BE BROUGHT FROM HOME ON A VOLUNTARY BASIS. OTHERWISE, THEY WILL BE FURNISHED BY THE SCHOOL.

4.2. Secondary Schools

- **4.2.1.** Secondary students are students enrolled in a middle school, junior high, or high school.
- **4.2.2.** Utah law permits the charging of fees to secondary students. No fee may be charged to or requested of secondary student unless the fee has first been approved by the Board and listed on the applicable Middle School, Junior High, or High School Fee Schedule.
- **4.2.3.** Secondary students may be required to provide student supplies. Student supplies are items which are the personal property of a student which, although used in the instructional process, are also commonly purchased and used by persons not enrolled in the class or activity in question and have a high probability of regular use in other than school-sponsored activities. Student supplies include:
 - 4.2.3.1. pencils;
 - 4.2.3.2. paper;
 - 4.2.3.3. notebooks;
 - 4.2.3.4. crayons;
 - **4.2.3.5.** scissors;
 - **4.2.3.6.** basic clothing for healthy lifestyle classes; and

- **4.2.3.7.** similar personal or consumable items over which a student retains ownership.
- **4.2.4.** Student supplies do not include items listed in subsection 4.2.3 if the school requests or requires a specific brand, color, or special imprint in order to create a uniform appearance not related to basic function.
- 4.2.5. Except for student supplies as described in subsection 4.2.3, students cannot be required or requested by a teacher or other person to pay fees or provide any materials, money, or any other thing of value unless that requirement has been approved by the Board of Education and included in the District Fee Schedule. No fee is considered optional, and ALL fees are subject to fee waivers under Section 6 of this policy.
- **4.2.6.** No teacher, coach, or other person acting as a representative of the school may sponsor a summer camp or other out-of-season activity unless the costs are within the limits approved by the Board of Education and included on the fee schedule. Fees for summer and out-of-season activities are subject to the waiver provisions of section 6.
- **4.2.7.** Expenditures for uniforms, costumes, clothing, and accessories (other than items of typical student dress) which are required for participation in choirs, pep clubs, drill teams, athletic teams, bands, orchestras, or other student groups, are fees requiring approval by the Board of Education and are subject to fee waivers.
- **4.2.8.** Expenditures for student travel as part of a school team, student group, or other school-approved trip are fees requiring approval by the Board of Education and are subject to fee waivers.
- **4.2.9.** Activities and competitions sponsored by the Utah High School Activities Association (UHSAA) must adhere to applicable UHSAA budget restrictions.
- **4.3.** Fee Schedules for the District, listing all approved fees, shall be adopted at least once each year by the Board of Education in a regularly scheduled public meeting. The approved District Fee Schedules will be available to parents/guardians prior to the beginning of each school year.

5. LIMITATIONS ON FEES

- **5.1.** Consistent with this policy, students may be charged reasonable fees as listed in the applicable Fee Schedule.
- **5.2.** No employee may charge a fee or request something of monetary value that is not a fee approved by the Board and listed on the applicable fee schedule.
- 5.3. A fee charged to a student must be equal to or less than the actual cost to the district of the student's participation in the activity for which the fee is charged. The calculation of the cost of a program or activity may not include the cost of revenue lost to fee waivers. A school may not use revenue collected through fees to offset the cost of fee waivers by requiring students and families who do not qualify for fee waivers to pay an increased fee amount to cover the costs of students and families who qualify for fee waivers.
- **5.4.** No fee may supplant or subsidize any other fee or be charged to cover any fee waiver.
- **5.5.** Each fee schedule adopted by the Board must include the following:
 - **5.5.1.** The specific amount of each fee;
 - **5.5.2.** The total amount a student may be charged for each activity, class, or program if a student is charged multiple fees related to one activity, class, or program;
 - **5.5.3.** A statement referencing the fee waiver policy and appeal information;
 - **5.5.4.** A spending plan for each fee;

- **5.5.5.** A per-student annual maximum fee amount for participation in all activities. Anything earned through an individual fundraiser is included.
- **5.6.** Beginning with the 2022-2023 school year, a fee schedule may not include a textbook fee.
- **5.7.** In project-related courses, projects required for course completion shall be free.

6. FEE WAIVERS AND APPEALS

- **6.1.** Fees will be waived for students who qualify for fee waiver under Utah law. Fees may be waived for other reasons at the discretion of the principal.
 - 6.1.1. If a family's income does not exceed the statewide defined standard (eligible for free or reduced lunch under federal law), or if the student receives Supplemental Security Income (SSI) payments, or if the family is receiving Temporary Assistance to Needy Families (TANF) or Supplemental Nutrition Assistance Program benefits (food stamps), or if the student was placed in the home by the government as a foster student, or if the student is in state custody, the student qualifies for a fee waiver under Utah law, and the school must waive fees.
 - **6.1.2.** If a family is having a financial emergency caused by job loss, major illness, or other substantial loss of income beyond the family's control, the student may be eligible for fee waiver even if other eligibility criteria are not met. The school principal is empowered to make a determination of eligibility in those cases. Verification may be collected as appropriate for the situation.
 - **6.1.3.** Parents/Guardians may, at their discretion, apply for partial fee waivers. Those requests will be processed in the same manner as requests for waiver of all fees. Unless parents/guardians have specifically requested a partial fee waiver, all fees must be waived for eligible students.
- **6.2.** All fee waiver requests must be handled confidentially and without placing undue burden on the student or family.
- 6.3. Fee Waiver Administrator
 - **6.3.1.** The principal at each school shall designate at least one administrator (principal, assistant principal, or dean of students) to act as a "Fee Waiver Administrator." The designated individual shall:
 - **6.3.1.1.** be trained in and have a knowledge and understanding of school fees, the fee waiver process, and student data privacy laws; and
 - **6.3.1.2.** work in an appropriate setting to facilitate confidential conversations and documents.
 - **6.3.2.** The Fee Waiver Administrator shall be responsible to:
 - **6.3.2.1.** review fee waiver applications and verification documents;
 - **6.3.2.2.** grant or deny fee waiver requests;
 - **6.3.2.3.** compile all logs and maintain fee waiver documents in compliance with the Family Educational Rights and Privacy Act (FERPA); and
 - **6.3.2.4.** report fee waiver information.
 - **6.3.3.** The Fee Waiver Administrator's contact information will be available on the school's website with other school fee information and in student registration materials.
 - **6.3.4.** A student may not assist in the fee waiver approval process.

- **6.4.** A parent/guardian may apply for a fee waiver by submitting a Fee Waiver Application to the fee waiver administrator. Application forms are to be made available to all parents and guardians before the beginning of each school year and should also be available on each school's website.
 - 6.4.1. A student who has submitted a Fee Waiver Application is not required to pay a fee while the school administrator considers the application. The following documentation may be used to verify fee waiver eligibility: documentation of household income in the form of a current pay stub or tax return (approval for eligibility of school lunch is not enough); for SSI, a benefit verification letter; for TANF, a letter of decision covering the period for which the fee waiver is sought from Utah Department of Workforce Services; for foster custody, the student in custody required intake form and school enrollment letter or both provided by the case worker from the Utah Division of Child and Family Services.
 - 6.4.2. Approval or denial of applications will be determined by the school administrator based on established Utah state and federal guidelines. The administrator will inform the student and the student's parent/guardian of the decision. If the application is denied, the school administrator will provide to the parent/guardian a Decision and Appeal Form. The form will explain the reason the application was denied and how to appeal the decision. If a parent/guardian appeals the denial of fee waivers, the fee will not need to be paid until the appeal is decided.
 - 6.4.3. All information related to the application, including the fact that a student or parent requested a waiver, will be kept confidential. The fee waiver application process will have no visible indicators that could lead to identification of fee waiver applicants. Following the final approval/denial of the fee waiver application, eligibility documentation will be returned to the parent or destroyed. The school will keep a record of the application itself (the fees being requested for waiver) and the fee statement (the fees that were waived) until four (4) years after the student has left the District and then destroy them. See Utah Division of Archives and Records Service, General Retention Schedule, GRS-1522.
 - **6.4.4.** Fee waiver documentation may be required at any time by the school, or a parent may ask for review for good cause. Schools may transfer fee waiver information to other schools to which students advance or transfer.
- **6.5.** Fee waiver eligible students must be able to enroll and participate fully in any class or activity sponsored by the school regardless of whether it is during the regular class day or after school or during the summer without paying a fee. "Non-waivable" or "optional" fees do not exist.
 - **6.5.1.** Driver's education programs which are school sponsored are fee waiver eligible. Fees paid to the Department of Motor Vehicles are NOT eligible for waiver, but any fees required as part of the course must be waived for eligible students. Fees for driver's education programs that are provided by a community education program are not subject to fee waivers.
 - **6.5.2.** The cost of rental of the graduation cap and gown is a waivable fee.

7. ALTERNATIVES IN LIEU OF FEES

- **7.1.** Nebo School District schools may provide alternatives to fee waivers for secondary students who are not eligible for fee waivers but who still need assistance with their fees. Alternatives to fee waivers may not be required of students.
 - **7.1.1.** Alternatives to waiving school fees may include such things as a reasonable requirement for tutoring of other students, custodial work, or other service at the school. School or community service requirements and fundraising activities must be appropriate to the age, physical condition, and maturity of the student, and must be

conducted in such a way that students are not subjected to embarrassment, ridicule, or humiliation. In addition, school or community service requirements and fundraising activities must avoid excessive burdens on students and families and give proper consideration to a student's education and transportation needs and other responsibilities.

7.1.2. Schools may not require installment payments, IOUs, or other delayed payment plans in lieu of fee waivers. Schools may allow parents/guardians, at their request, to pay fees in installments over a period of time, but may not require it.

8. APPROVAL, NOTICE, AND TRAINING

- **8.1.** The Board shall annually review and approve this policy and the fee schedules for the upcoming school year.
 - **8.1.1.** The review and approval must take place at a regularly scheduled Board meeting.
 - **8.1.2.** In addition to the notice requirements found in <u>Nebo School District Policy BD</u>, <u>Board of Education Meetings</u>, notice of the meetings in which this policy will be discussed or approved shall include notice to parents and students using the same form of communication regularly used by the District to communicate with parents.
 - **8.1.3.** Before the Board approves the policy and fee schedules, members of the public must be given opportunities to comment on the proposed fee schedules during at least two Board meetings. Members of the public are encouraged to participate in the development of the policy and fee schedules as instructed on the agenda for each Board meeting.
- **8.2.** The approved policy and fee schedules will be made available to each student and parent. They will be available on each school's website and included with registration materials.
- **8.3.** The approved policy and fee schedules will be made available in Spanish. If a student or parent's first language is a language other than English or Spanish, a school administrator shall contact the parent and may provide an interpreter to help the parent understand the policy and fee schedules.
- **8.4.** Notices on school websites and in registration materials must be on forms provided by the Utah State Board of Education.
- **8.5.** The District shall provide annual training for employees on this policy and the fee schedules, specific to each employee's job function.

9. VOLUNTARY DONATIONS

- **9.1.** In accordance with Nebo School District Policy KABA, Donations, school personnel may ask parents or other adults for general donations of school supplies, equipment, or money. However, no employee may require donations. Likewise, no employee may disclose the names of students whose parents have or have not made donations, except that an administrator may choose to recognize a donation through the means permitted by Nebo School District Policy KACA, School Advertising Restrictions. No child may be penalized for not making a donation.
- **9.2.** Except as permitted by Nebo School District Policy KAC, School Fundraising Activities, employees may not request donations from students and may not request a donation in connection with an activity, class, or program that is provided, sponsored, or supported by the District or its schools.

10. COLLECTION OF UNPAID FEES

10.1. As more fully described in <u>Nebo School District Policy JNA</u>, <u>Collection of Delinquent Student Fees</u>, schools may pursue reasonable methods to collect fees, including collection agencies,

small claims, and opportunities to work for waivers. Schools may not withhold or reduce grades, credits, report cards, transcripts, or diplomas to enforce fee payment.

- **10.2.** A student may be denied the opportunity to participate in graduation ceremonies due to outstanding fees or non-waivable charges.
- 10.3. A school may withhold the records of a student who willfully defaces school property consistent with UTAH CODE ANN. § 53G-8-212.

Activities

1. PURPOSE AND PHILOSOPHY

The Board of Education recognizes that fundraising at the school level has become an important source of providing for needs over and above those available through regular District sources. The Board also recognizes that issues such as excessive solicitation of businesses and patrons, student safety, undue distractions and time commitments, and financial ethics can arise while Fundraising Activities are undertaken. The Board requires that great care and restraint be exercised by school level personnel in planning and implementing Fundraising Activities.

2. **DEFINITIONS**

- **2.1 "Crowdfunding"** is the practice of funding a project or venture by raising many small amounts of money from a large number of people, typically via the internet.
- 2.2 "Fundraiser" or "Fundraising Activity(ies)" means a school or District sponsored activity or event that uses students to generate funds. A fundraiser may involve the sale of goods or services, the solicitation of monetary contributions from individuals and/or businesses, or any other lawful means or methods using students to generate funds. The primary purpose of a Fundraiser is to raise monies to provide financial support to the school or any of its classes, groups, teams, or programs. As provided in this policy, certain Fundraising Activities may also be organized to benefit a particular charity or for other charitable purposes.
- **2.3** "Group Fundraiser" means a Fundraising Activity in which funds raised are used for the mutual benefit of the team or organization and not to offset the expenses of individual students.
- **2.4** "Individual Fundraiser" means a Fundraising Activity in which funds raised by each student are used to pay that individual student's costs.

3. ALTERNATIVE REVENUE STREAMS

- 3.1 In addition to the Fundraising Activities described in this policy, schools may permit certain alternative methods of raising revenue consistent with applicable District policies. If these alternative revenue streams do not use students, they are not considered Fundraisers and are therefore not subject to the restrictions on Fundraisers found in this policy. However, restrictions may be imposed by other District policies. The following are examples of alternative revenue streams.
 - 3.1.1 Unsolicited donations. A school may receive a donation that was not solicited by students and for which the donor receives no goods or services in return. Such receipt is not considered a Fundraiser but is subject to the provisions of Nebo School District Policy KABA, *Donations*. However, if students are used to solicit donations, the activity is a Fundraiser subject to this Policy KAC.
 - 3.1.2 Advertising. Consistent with Nebo School District Policy KACA, School Advertising Restrictions, schools may receive revenue through the sale of advertising. If students are not used to solicit or conduct the advertising, it is considered an alternative revenue stream rather than a Fundraiser and is not subject to the restrictions specific to Fundraisers found in this Policy KAC. However, if students are used to solicit or conduct the advertising, the activity is a Fundraiser subject to the restrictions of this Policy KAC, including, but not limited to, the limitation on number of Fundraisers found in Section 4.5 and the approval and disclosure requirements found in Section 5.1. No advertising may be conducted except as specifically permitted by Policy KACA.
 - 3.1.3 Unobtrusive programs that don't place pressure on students or parents to participate but that result in the school receiving goods or funds may be considered an alternative revenue stream rather than a Fundraiser. Such programs may include, but are not limited to, Box Tops for Education, Penny Wars, a container into which students may drop donated goods, or other similar arrangements that are passive in nature and do not advertise a for-profit business or entity. Principals must ensure that such arrangements do not undermine or detract from the school's obligation to educate students.
 - 3.1.4 The solicitation of direct donations from patrons may be allowed when the need and use of the funds is identified and approved by the school principal. If the solicitation is made without the use of students, it is considered an alternative revenue stream.

4. APPROVAL PROCESS

- 4.1 All Fundraising Activities must have prior approval by the school principal or designated assistant principal. If the Fundraising Activity is a schoolwide activity, the principal must complete the Nebo School District Schoolwide Fundraiser Parent Disclosure form. If the Fundraising Activity is being proposed by a team, group, or organization, the head coach or advisor is responsible for obtaining approval by completing and submitting the Nebo School District Request for Approval of Fundraising Activity and Parent Disclosure form (hereinafter "Approval Request and Disclosure"). The principal has absolute discretion to withhold approval of any Fundraising Activity. The principal's decision may not be appealed. Before giving approval, the principal or designee will review the following with the head coach or advisor:
 - **4.1.1** The purposes of the Fundraising Activity.
 - **4.1.2** How the money will be collected, accounted for, and spent, including finance and auditing procedures.
 - **4.1.3** Guidelines and directions that will be given to students regarding their participation.

- **4.1.4** Potential risks, including student safety, transportation issues, and appropriate supervision.
- **4.1.5** Measures taken to mitigate potential risks.
- **4.1.6** Possible issues related to federal or state law, contracts, or District policies, which include, but are not limited to:
 - **4.1.6.1** Utah State Risk Management Insurance
 - **4.1.6.2** Title IX of the Education Amendments Act of 1972
 - 4.1.6.3 Policy KA, School Facility Use
 - **4.1.6.4** Policy KAB, *PTAs*, *PTOs*, *Booster Clubs*, and *Other Parent Support Groups*
 - 4.1.6.5 Policy KABA, Donations
 - **4.1.6.6** Policy KACA, School Advertising Restrictions
 - **4.1.6.7** Policy KAD, Summer / Out-of-Season Activity Participation
 - **4.1.6.8** Policy KAA, Community Education
 - 4.1.6.9 Policy IICA, Student Educational Travel
 - **4.1.6.10** Policy DJA, Accounting Procedures
 - 4.1.6.11 Policy DJB, Purchasing
 - 4.1.6.12 Policy DLC, Personnel Travel
 - **4.1.6.13** Administrative Directive 3.3, Nonwaivable Charges
 - 4.1.6.13 Administrative Directive 5.1, Private, but Public Education Related Activities
- **4.2** Procedures Governing Interaction with Parents, Donors, and Other Organizations
 - 4.2.1 Before a schoolwide Fundraiser may commence, the principal shall ensure that a completed copy of the Schoolwide Fundraiser Parent Disclosure form is provided or made available to the parents of all students in the school. This requirement may be satisfied by posting the completed form online and providing parents with a link to it. No fundraising materials, including fliers or commercially produced literature, may be sent home with students or given to parents unless and until the disclosure form has also been made available. The form must identify the specific financial needs to be satisfied by the Fundraiser. The form must also describe the Fundraiser, including any involvement of students, staff, or third parties. The form must describe how the money will be collected and accounted for.
 - **4.2.2** For a team or group Fundraiser, once the proposed Fundraising Activity has been approved and the principal/assistant principal has signed the Approval Request and Disclosure, and before commencement of the Fundraising Activity, the head coach or advisor must give to all parents/guardians of students to be involved in the Fundraising Activity a complete copy of the Approval Request and Disclosure. This requirement may be satisfied by posting the completed form online and providing parents with a link to it.
 - **4.2.3** All interaction between employees, students, parents, donors, and other organizations during the Fundraising Activity must be in compliance with District

policies and procedures, especially but not limited to Nebo School District Policy KAB, *PTAs, PTOs, Booster Clubs, and Other Parent Support Groups* and Nebo School District Policy DJA, *Accounting Procedures*.

4.3 Disclosure of Financial Interest

- 4.3.1 If the coach, advisor, or other District employee who manages or oversees a fundraising activity also has a financial or controlling interest in or access to the bank account(s) of the fundraising organization or company, the employee must disclose such interest or access on the Approval Request and Disclosure before the activity will be approved.
- **4.3.2** If the administrator who approves a Fundraising Activity also has a financial or controlling interest in or access to the bank account(s) of the fundraising organization or company, the administrator must disclose such interest or access on the Approval Request and Disclosure form. A copy of this form must then be provided to the administrator's immediate supervisor.
- **4.3.3** Other than their normal hourly wage or stipend, no District employee may receive compensation in the form of profits, percentage of revenues, kickbacks, products, gifts, or anything of financial value as a result of a Fundraising Activity.

5. NUMBER AND FREQUENCY

- 5.1 One school-wide charitable Fundraiser per school per year may be allowed (i.e., Walk-a-Thon, Quarters for Christmas, etc.). When a charitable Fundraiser is held, proceeds must be given to the charity rather than to an individual or family, except that in exceptional circumstances the Director of Elementary Education or Director of Secondary Education may approve the giving of proceeds from a charitable Fundraiser to an individual or family. In such cases, the principal should advise the recipient to consult with the recipient's tax advisor or legal counsel regarding possible tax or other legal ramifications for receiving the proceeds.
- <u>5.2</u> In addition to a charitable Fundraiser, the Board recommends that each school have only one schoolwide Fundraiser per year.
- 5.25.3 The Board also recommends that each team or group have only one Fundraiser per year.

 Additional Fundraisers beyond one schoolwide and one group require approval from the applicable director.

6. PERMITTED FUNDRAISING ACTIVITIES

- 6.1 Projects where school organizations buy or have donated raw materials, turn them into a finished product under the supervision of school personnel, and sell them to the public may be allowed. When food is prepared, a food handler's permit will be required. The selling of baked goods, or other food items intended for human consumption, which have been prepared at home by students or parents/guardians is not allowed.
- **6.2** Students may solicit sales, pledges, or contributions from persons known to the student or known to their parents/guardians (i.e., friends, neighbors, relatives, co-workers, business associates, etc.). However, students may not engage in such solicitation from persons not known to the student/parent/guardian. **Door-to-door sales to individuals not known to the student or parent are prohibited.**
- **6.3** Subject to the provisions herein, schools may enter into contractual agreements with vendors or other third parties to conduct Fundraisers.
 - **6.3.1** School Visitation Pass Required
 - **6.3.1.1** Vendors and other third parties must be approved by the Operations Department and issued a School Visitation Pass, as described in Nebo

- School District Policy KACA, *School Advertising Restrictions*, before contacting a school or employee to solicit involvement in a Fundraiser.
- **6.3.1.2** Employees contacted by a vendor who does not have a current School Visitation Pass may not enter into any contract with the vendor or otherwise use the vendor's products or services but shall instead refer the vendor to the Operations Department.
- **6.3.1.3** The Operations Department will assure that the vendor is aware of the provisions of this policy and any other applicable District policies and procedures, and that the vendor has satisfied all licensing and registration requirements in accordance with Utah law.
- **6.3.1.4** Issuance of a School Visitation Pass does not indicate District sponsorship of the vendor, its products, or its services, nor does it indicate that the vendor's proposal complies with District policies. School administrators must evaluate a vendor's involvement in a Fundraiser and assure compliance before approving the Fundraiser.
- **6.3.1.5** Any vendor who purports to be District-sponsored, who intentionally violates District policy, or who provides false or misleading information about another vendor will have its School Visitation Pass revoked for the remainder of the school year.
- **6.3.2** Contracts with Fundraising vendors must be signed by the school administrator.
- **6.3.3** When a Fundraiser is conducted under a contract with a third party, only those funds received by the school are Public Funds.
- 6.4 The solicitation of money, goods, and/or services from local businesses is a Fundraiser and is subject to the requirements of this policy, including school administrative approval. School administrators are encouraged to be sensitive to the number of school Fundraising Activities which solicit directly from local businesses and must strictly enforce the prohibition against multiple Fundraisers. School administrators shall document and impose limits upon the number and type of school Fundraising Activities that are permitted to approach local businesses for contributions.
- 6.5 "Adopt a School" or other school-business partnerships which result in the school receiving funds, services, or materials may be allowed and are encouraged. Partnerships must be formed in accordance with Nebo School District Policy KACA, School Advertising Restrictions.
- 6.6 Certain Fundraisers may be coordinated with the Nebo Education Foundation with authorization by both the school principal and the executive director of the Nebo Education Foundation. In such event, the donations by individuals, businesses, and entities may be characterized as a charitable donation and possibly be tax deductible. In order for donations to be characterized as a charitable donation for tax purposes, the donor must not receive any goods, services, or other consideration in return for the donation.
- **6.7** Crowdfunding activities are Fundraisers and are subject to all the requirements set forth in this policy applicable to Fundraisers. If a crowdfunding activity uses a third-party vendor, the vendor is subject to all requirements found in subsection 6.3.

7. RECEIPT AND USE OF FUNDRAISING PROCEEDS

- **7.1** Proceeds from Fundraising Activities must be received in compliance with Nebo School District Policy DJA, *Accounting Procedures*.
- **7.2** The District, including any of its schools, maintains full discretion on whether to accept any proceeds from Fundraising Activities. Consistent with Nebo School District Policy KABA,

Donations, the District may provide a charitable donation receipt for fundraising proceeds if the donor received no goods or services in exchange for the proceeds.

- **7.3** The proceeds of any Fundraising Activity may be used only consistent with this section and only for the purpose identified and approved in the Approval Request and Disclosure.
- **7.4** Proceeds of Fundraising Activities may not be used to hire additional personnel or to cover or augment the salary/stipend of existing personnel.
- 7.5 Surplus or unused funds from Fundraising Activities, whether Individual or Group, must be used for other immediate program expenses or they revert to the school. In no case will surplus funds revert to students or parents, and surplus funds should not be held over from year to year.
- **7.6** Students who earn money through an Individual Fundraiser may be credited an appropriate amount against any costs that are assessed individually to them by the organization sponsoring the Fundraiser. However, surplus or unused funds revert to the team/group sponsoring the Fundraiser and not to the student or parent.
- 7.7 The costs associated with each school program are divided into four three categories: (a) facilities expenses, (b) basic program expenses, (c) uniform expenses, and (dc) travel expenses.

7.7.1 Facilities Expenses

- **7.7.1.1** Facilities expenses include the purchase, construction, renovation, improvement, and maintenance of any facility or long-term equipment used by school or District programs.
 - **7.7.1.1.1** Facilities include, but are not limited to, fields, stadiums, bleachers, score boards, marquees, gymnasiums, tennis courts, auditoriums, training facilities, etc.
 - 7.7.1.1.2 Long-term equipment is equipment that is typically used for more than one year and includes but is not limited to items such as blocking sleds (football), wrestling mats, pitching machines, batting cages, basketball hoops, etc.
- 7.7.1.2 Fundraising proceeds are not generally allowed for facilities expenses. No Fundraising Activity may be held for purposes of covering or supplementing facilities expenses unless specific approval is obtained from the Superintendent, the Director of Operations, and the applicable Secondary or Elementary Director.

7.7.2 Basic Program Expenses

- 7.7.2.1 Basic program expenses are the expenses required to run a particular school program as determined by the Department of Secondary Education or the Department of Elementary Education. Basic program expenses include but are not limited to the following: consumable supplies; officials/referees; uniforms, except as provided in Section 5.8.3 below; equipment; and transportation and admission to in-season games, tournaments, and performances.
- 7.7.2.2 Participation fees as defined and listed in Nebo School District Policy JN, Student Fees are expected to cover basic program expenses. Fundraising proceeds are not generally used to cover or supplement basic program expenses; however, approval for specific needs may be granted by the school principal. Fundraising Activities held to raise money for basic program expenses must be held for specific items enumerated in the

Approval Request and Disclosure and not merely as general program needs.

7.7.3 Uniform Expenses

- 7.7.3.1 Uniform expenses include the cost of uniforms for those organizations specifically listed in the Nebo School District High School Fee Schedule under the category Maximum Per-Student Uniform Expenditure.
- 7.7.3.2 Proceeds of Individual and Group Fundraisers may be used to cover or supplement uniform expenses up to the maximum amount allowed under the Fee Schedule. The total amount spent on uniforms may not exceed the amount allowed under the Fee Schedule regardless of whether the funds come from Fundraisers, students, or a combination of both.

7.7.47.7.3 Travel Expenses

- 7.7.4.17.7.3.1 Travel expenses include all costs associated with overnight travel as defined in Nebo School District Policy IICA, Student Educational Travel, including but not limited to transportation, housing, meals, registration fees, entrance/admissions fees, and other costs as disclosed to and approved by parents as required by Policy IICA.
- 7.7.4.27.7.3.2 Proceeds of Individual and Group Fundraisers may be used to cover or supplement student travel expenses.

8. GENERAL RULES AND RESTRICTIONS

The following specific rules govern all Fundraising Activities. The Board authorizes the Superintendent's staff to develop Administrative Directives, practices, and procedures to clarify these rules and restrictions as questions arise.

- **8.1** Consistent with Nebo School District Policy DJA, *Accounting Procedures*, fundraising revenues should be accounted for at an individual contribution level or participation level. Participation logs should be retained.
- **8.2** A District tax exempt status number may be used only in accordance with Utah State Tax Commission guidelines and applicable Nebo School District policies, including but not limited to Nebo School District Policy DJA, *Accounting Procedures* and Nebo School District Policy DJB, *Purchasing*.
- **8.3** A receipt for donations shall be issued in accordance with Nebo School District Policy KABA, *Donations*.
- 8.4 No rewards or prizes may be offered to groups, classes, or students unless specifically approved by the school principal and by the applicable Elementary or Secondary Director. No rewards, prizes, commissions, kickbacks, or other direct or indirect compensation may be received by any District employee or volunteer.
- **8.5** Student grades or citizenship standing shall not be affected by a student's ability or willingness to participate in any Fundraising Activity.
- **8.6** Sales quotas for students may not be a part of any Fundraising Activity, and students may not be required to pay for any unsold items which are returned to the school.
- 8.7 Students may not participate in a Fundraiser for a team or organization to which they do not belong. For example, a sport for which students must try out may not hold a Fundraiser that uses students trying out for the team but who have not yet been selected for the team. Only those students who make the team may participate in the Fundraiser.

- **8.8** Students shall not be required to participate in a Fundraising Activity as a condition for belonging to a team or group; nor shall a student's participation or lack thereof affect his/her play time or standing on said team or group. Students must be given the opportunity to directly pay the costs that are assessed to them. Students may not be assessed fees in excess of the Board approved Fee Schedule.
- **8.9** Students who qualify for fee waivers are encouraged to participate in Fundraising Activities as part of the requirement to work in exchange for the fees waived. Sales quotas may not be established as a condition for fee waiver.
- **8.10** An individual student or group of students may not use the facilities or resources of the school to conduct a personal fundraising effort not sponsored by the school except on a rental basis as outlined in Nebo School District Policy KA, *School Facility Use*.
- 8.11 Raffles are illegal in Utah and are, therefore, prohibited as a Fundraising Activity. A raffle is defined as an activity in which people purchase an opportunity to win something which is ultimately determined by chance.
- **8.11**8.12 Information related to a student's fundraising efforts, including amounts raised, items sold, or people contacted, must be kept confidential and not shared with other students.

1. PURPOSE AND PHILOSOPHY

The Family and Medical Leave Act of 1993 (FMLA), 29 U.S.C., §2601, et seq. and its implementing regulations, 29 C.F.R., Part 825, requires covered employers to provide grant eligible employees up to twelve (12) weeks of unpaid, job-protected leave per year to "eligible" employees for certain family and medical reasons. Eligible employees are also entitled to up to twelve (12) weeks of leave because of "anyand for a qualifying exigency" as described herein, arising out of the fact that the spouse, son, daughter, or parent of the employee is on active duty, or has been notified of an impending call to active duty status, in support of a contingency operation. The Secretary of Labor of the United States issues regulations defining "any qualifying exigency." This policy outlines rights, responsibilities, and procedures related to FMLA leave. The FMLA statute and regulations provide more detailed descriptions and should be consulted when questions arise. Employees are eligible if they have worked for a covered employer for at least one (1) year, and for 1,250 hours over the previous twelve (12) months, and if there are at least fifty (50) employees within seventy five (75) miles.

2. DEFINITIONS

For purposes of this policy, the following definitions apply. The definitions are derived from federal regulations found at 29 CFR 825.102, which supersede any missing or conflicting provisions in this policy.

- **1.1.** "Covered employer" Any employer with fifty (50) or more employees within seventy-five (75) miles.
- 4.2.2.1. "Eligible employees" means an Eemployees who have has been employed by the District for a total of at least 12 months on the date on which any FMLA leave is to commence and who has worked for the District for at least 1,250 hours during the immediateim mediately preceding twelve (12) month period prior to any request for leave under this policy, or any certified employee of the District who has been employed full-time for at least twelve (12) months by the District.
- **1.3.2.2. "Employment benefits"** <u>means</u> Aall benefits provided by the District to its employees, such as group life insurance, health insurance, disability insurance, sick leave, annual leave, educational benefits, and pension or retirement benefits.
- 1.4.2.3. "Health care provider" means Aa licensed doctor of osteopathy or medicine and others listed in the applicable regulation.

2.4. "Instructional Employee"

- 2.4.1. means an employee whose principal function is to teach and instruct students in a class, small group, or individual setting and includes not only teachers but also coaches, driving instructors, and special education assistants such as signers for the hearing impaired;
- 2.4.2. does not mean teacher assistants or aides who do not have as their principal function actual teaching or instructing, nor auxiliary personnel such as counselors, psychologists, curriculum specialists, child nutrition workers, maintenance workers, bus drivers, or other primarily noninstructional employees.
- **1.5.**2.5. "Parent" means Tthe natural biological, or adoptive, step, or foster parent of a child, or a child's legal guardian who acts in the place of a parent.
- **1.6.** "Qualifying exigency" A military action where United States forces are involved and are defined by the Secretary of Labor.
- **1.7.**2.6. "Serious health condition" means Aan illness, injury, impairment, or physical or mental condition that requires:
 - **1.7.1.** 2.6.1. Inpatient care consisting of an overnight stay in a hospital, hospice, or residential medical facility and subsequent treatment; OR
 - 1.7.2.2.6.2. Continuing treatments by a health care provider, which includes:
 - 1.7.2.1.2.6.2.1. Periods of inability to work more than three (3) consecutive calendar days that also involves treatment two (2) or more times by a health care provider or at least one (1) time which results in a regimen of continuing treatment;
 - 1.7.2.2.2.6.2.2. Any period of incapacity due to pregnancy or prenatal care;
 - 4.7.2.3.2.6.2.3. Any period of incapacity or treatment due to a chronic, serious health condition which:
 - **1.7.2.3.1.** Requires periodic visits for treatment by a health care provider, or by a nurse or physician's assistant under direct supervision of a health care provider;
 - 1.7.2.3.2.2.6.2.3.2. Continues over an extended period of time (including recurring episodes of a single underlying condition); AND
 - 1.7.2.3.3. 2.6.2.3.3. May cause episodic rather than a continuing period of incapacity (e.g., asthma, diabetes, epilepsy, etc.);
 - 4.7.2.4.2.6.2.4. A period of incapacity which is permanent or long-term due to a serious health condition for which treatment may not be effective, such as Alzheimer's disease, severe stroke, or terminal stages of a disease; OR
 - 1.7.2.5.2.6.2.5. Any period of absence to receive multiple treatments by a health care provider for restorative surgery or for treatment leading to incapacity for more than three (3) consecutive calendar days in the absence of medical intervention or treatment, such as cancer (chemotherapy, radiation, etc.), severe arthritis (physical therapy), or kidney disease (dialysis).
- 4.8.2.7. "Son or daughter" means Aa biological, adopted, or foster child; a stepchild; or a legal ward of a person who acts as parent. A child is: (a) less than eighteen (18) years of age; or (b) older than eighteen (18) years, but incapable of self-care due to mental or physical disability.

1.9.2.8. "Spouse" means—A a legal husband or wife as described in the Constitution of the State of Utah.

2.3. REASONS FOR TAKING LEAVE

- **2.1.**3.1. Unpaid leave must be granted The District will grant leave, as described in section 4, to eligible employees for any of the following reasons:
 - 3.1.1. To care for the employee's child after For the birth of a son or daughter, and to care for the newborn child., placement for adoption, or foster care;
 - **2.1.1.3.1.2.** For placement with the employee of a son or daughter for adoption or foster care.
 - 2.1.1.1.3.1.2.1. A father, as well as a mother, can take family leave for the birth, placement for adoption, or foster care of a child;
 - 3.1.3. To care for the employee's spouse, son or daughter, or parent who has a serious health condition.
 - 2.1.2.3.1.4. Because of for a serious health condition that makes the employee unable to perform the functions of the employee's job.; OR
 - 3.1.5. Because of any qualifying exigency arising out of the fact that the employee's spouse, son, daughter, or parent is a military member on covered active duty (or has been notified of an impending call or order to covered active duty status.
 - 3.1.6. To care for For a spouse, son, daughter, parent, or next-of-kin of a covered service member who is recovering from with a serious injury or illness or injury if the employee is the spouse, son, daughter, parent, or next of kin of the covered servicemember.
 - 3.1.6.1. A covered servicemember means a current member of the armed forces, as defined in the FMLA regulations, who is undergoing medical treatment, recuperation, or therapy, is otherwise in outpatient status, or is otherwise on the temporary disability retired list, for a serious injury or illness, or a covered veteran as defined in the FMLA regulations.
 - 3.1.6.2. A serious injury or illness means an injury or illness sustained in the line of duty on active duty, or that was aggravated by service in the line of duty on active duty and that may render the servicemember medically unfit to perform the duties of the member's office, grade, rank, or rating. or is otherwise on the temporary retirement list,
- 3.2. The right to take leave under FMLA applies equally to male and female employees. A father, as well as a mother, can take family leave for the birth, placement for adoption, or foster care of a child.
- **3.3.** An expectant mother may take FMLA leave before the birth of the child for prenatal care if her condition makes her unable to work.

4. AMOUNT OF LEAVE

- **4.1.** An eligible employee is entitled to a total of 12 workweeks of leave during any 12-month period for any of the reasons listed in paragraphs 3.1.1 through 3.1.5.
- 4.2. An eligible employee is entitled to a total of up to twenty-six (26) workweeks of leave in during a single twelve (12) month period under subsection 3.1.6 to care for the covered service member.

- 4.3. <u>During the This military caregiver leave is available during a "single twelve (12-)</u> month period described in paragraph 4.2, during which anthe eligible employee is entitled to a combined total of twenty-six (26) workweeks of all types of FMLA leave.
- **4.4.** To calculate an employee's available FMLA leave, the District uses a rolling 12-month period measured backward from the date the employee uses any FMLA leave.
- 4.5. Employees eligible for FMLA leave who have accrued sick leave are required to substitute the accrued sick leave for FMLA leave, consistent with 29 CFR 825.207, so that the sick leave and FMLA leave run concurrently.
 - 4.5.1.Under the regulations, the term "substitute" means that the paid sick leave will run concurrently with the unpaid FMLA leave, so that both are used simultaneously. Thus, a single absence that qualifies for both sick leave and FMLA leave will use up both a day of accrued sick leave and a day of allotted FMLA leave.
 - **4.5.2.**The requirement to take sick leave and FMLA leave concurrently is applicable only when the condition for which the FMLA leave is taken also qualifies for sick leave.
- 2.2.4.6. FMLA leave may be taken intermittently or on a reduced leave schedule under certain circumstances. Intermittent leave is FMLA leave taken in separate blocks of time due to a single qualifying reason. A reduced leave schedule is a leave schedule that reduces an employee's usual number of working hours per workweek, or hours per workday.
- 2.3. At the employee's or employer's option, certain kinds of paid leave may be substituted for unpaid leave.

5. INSTRUCTIONAL EMPLOYEES

- 5.1. If an eligible instructional employee needs intermittent leave or leave on a reduced leave schedule to care for a family member with a serious health condition, to care for a covered servicemember, or for the employee's own serious health condition, which is foreseeable based on planned medical treatment, and the employee would be on leave for more than 20 percent of the total number of working days over the period the leave would extend, the District may require the employee to choose either to:
 - **5.1.1.** Take leave for a period or periods of a particular duration, not greater than the duration of the planned treatment; or
 - 5.1.2. Transfer temporarily to an available alternative position for which the employee is qualified, which has equivalent pay and benefits and which better accommodates recurring periods of leave than does the employee's regular position.
- 5.2. If an eligible instructional employee begins FMLA leave more than five weeks before the end of a semester, the District may require the employee to continue taking leave until the end of the semester if
 - 5.2.1. The leave will last at least three weeks, and
 - **5.2.2.**The employee would return to work during the three-week period before the end of the term.
- 5.3. If an eligible instructional employee begins FMLA leave during the five-week period before the end of a semester because of the birth of a son or daughter; the placement of a son or daughter for adoption or foster care; to care for a spouse, son, daughter, or parent with a serious health condition; or to care for a covered servicemember, the District may require the employee to continue taking leave until the end of the term if

- 5.3.1. The leave will last more than two weeks, and
- **5.3.2.**The employee would return to work during the two-week period before the end of the term.
- 5.4. If an eligible instructional employee begins leave during the three-week period before the end of a semester because of the birth of a son or daughter; the placement of a son or daughter for adoption or foster care; to care for a spouse, son, daughter, or parent with a serious health condition; or to care for a covered servicemember, the District may require the employee to continue taking leave until the end of the semester if the leave will last more than five working days.
- 5.5. If an employee is required to take leave until the end of a semester under subsection 5.2, 5.3, or 5.4, only the period of leave until the employee is ready and able to return to work shall be charged against the employee's FMLA leave entitlement.

3.6. ADVANCE NOTICE AND MEDICAL CERTIFICATION

- 3.1.6.1. The employee may be required to provide advance leave notice and medical certification. Taking of leave may be denied if requirements are not met.
 - 3.1.1.6.1.1. The employee ordinarily must provide thirty (30) days advance notice when the leave is "foreseeable."
 - **3.1.2.** An employer The District may require medical certification to support a request for leave because of a serious health condition, and may require second or third opinions (at the employer's expense) and a fitness for duty report to return to work.
 - 3.1.3.6.1.3. The employee shall make a reasonable effort to schedule treatment so as not to unduly disrupt the operations of the District.
 - **3.1.4.**6.1.4. Medical certification must include the following:
 - 3.1.4.1.6.1.4.1. The date on which the serious health condition commenced.
 - 3.1.4.2.6.1.4.2. The probable duration of the condition.
 - **3.1.4.3.** If additional treatments will be required for the condition, an estimate of the probable number of such treatments.
 - 3.1.4.4.6.1.4.4. Which part of the definition of "serious health condition," if any, applies to the patient's condition and the medical facts which support the certification, including a brief statement as to how the medical facts meet the criteria of the definition.
 - 3.1.4.5.6.1.4.5. If medical leave is required for the employee's absence from work because of the employee's own condition (including absences due to pregnancy or a chronic condition), whether the employee:
 - **3.1.4.5.1.** Is unable to perform work of any kind.
 - 3.1.4.5.2.6.1.4.5.2. Is unable to perform any one or more of the essential functions of the employee's position, including a statement of the essential functions the employee is unable to perform, based on either information on a statement from the employer of the essential functions of the position or, if not provided, discussion with the employee about the employee's job functions.
 - 3.1.4.5.3.6.1.4.5.3. Must be absent from work for treatment.

3.1.4.5.4.6.1.4.5.4. A statement that the serious medical condition prevents the employee from performing the tasks of the position or that requires the employee to attend and care for a son, daughter, spouse, or parent.

4.7. JOB BENEFITS AND PROTECTION

- **4.1.**7.1. For the duration of FMLA leave, the employer must maintain the employee's benefits, including health coverage under any "group health plan," as described above.
- 4.2.7.2. Upon return from FMLA leave, most employees must be restored to their original or equivalent positions with equivalent pay, benefits, and other employment terms.
- 4.3.7.3. The use of FMLA leave cannot result in the loss of any employment benefit that accrued prior to the start of an employee's leave.
- 4.4.7.4. If an employee fails to return to work after leave expires for reasons other than continuation, recurrence, or onset of a serious health condition of the employee, son, daughter, or spouse, then the District may recover the premium paid for maintaining coverage for the employee during the leave period.

5.8. UNLAWFUL ACTS BY EMPLOYERS

- **5.1.**8.1. FMLA makes it unlawful for any employer to:
 - **5.1.1.**8.1.1. Interfere with, restrain, or deny the exercise of any right provided under FMLA; OR
 - 5.1.2.8.1.2. Discharge or discriminate against any person for opposing any practice made unlawful by FMLA or for involvement in any proceeding under or relating to FMLA.

6.9. ENFORCEMENT

- 6.1.9.1. The U.S. Department of Labor is authorized to investigate and resolve complaints of violations.
- 6.2.9.2. An eligible employee may bring civil action against an employer for violations.
- 9.3. FMLA does not affect any federal or state law prohibiting discrimination, or supersede any state or local law or collective bargaining agreement which provides greater family or medical leave rights.

10. NOTICE

- 10.1. The District shall post in a conspicuous place on school premises or websites a notice of rights under this policy. The notice must meet the criteria found in 20 CFR 825.300.
- 6.3.10.2. Upon receipt of a written request for FMLA leave, the District will provide the employee written notification of the status of the leave request within 5 working days.

1. PURPOSE AND PHILOSOPHY

- 1.1. The Board of Education of Nebo School District recognizes that every student should have the opportunity to learn in an environment which is safe, conducive to the learning process, and free from unnecessary disruption. Certain substances (the prohibited substances) threaten that safe environment because they may cause a condition of intoxication, inebriation, excitement, stupefaction, or dulling of the brain or nervous system. The use, possession, influence, distribution, or sale of prohibited substances such as tobacco, alcohol, drugs, paraphernalia, or other similarly harmful substances jeopardizes this safe environment and constitutes a hazard to the welfare of students and faculty, in addition to generally being illegal under the laws of the state of Utah and the United States.
- 1.2. The Board recognizes that new substances are continually being developed, marketed, and used in society. Many become available to students before laws and policies can address them by name, and many have multiple names and variations, making a comprehensive list infeasible. Therefore, the definitions and list of prohibited substances in this policy are intentionally written broadly and may contain overlapping elements. They are meant to be interpreted broadly to give school and District administrators wide latitude in addressing student safety. The omission of a specific name, product, or substance from this policy does not remove an administrator's ability to prohibit it or issue discipline under Nebo School District Policy JD, Student Conduct and Discipline.
- 1.3. In order to maintain a secure and orderly learning environment, the Board hereby adopts this policy to assist students in avoiding the dangers of the prohibited substances outlined herein. The Board recognizes the benefits of helping students avoid and overcome substance abuse and intends that the District apply restorative practices before discipline that is strictly punitive.

2. PROHIBITED SUBSTANCES

2.1. Unless specifically authorized by paragraph 2.2 below, no student may use, possess, distribute, or be under the influence of any of the following while on school or District property, in any vehicle dispatched by the District, or at any school or District-sponsored activity. These prohibitions apply whether or not the actions occur during regular school hours.

2.1.1. Addictive Prescription Drugs

- **2.1.1.1.** These are drugs for which a prescription is required and which have a high potential for abuse and may lead to severe or moderate psychological or physical dependence.
- **2.1.1.2.** All drugs listed in Schedule II of the federal <u>Controlled Substances Act</u>, and most from Schedule III, fall under this category. Examples include, but are not limited to, oxycodone (such as Percocet and OxyContin), Fentanyl, Morphine, hydrocodone/codeine (such as Lortab and Vicodin), and Paregoric.

2.1.2. Alcohol

- **2.1.2.1.** Alcohol is a chemical and a drug typically found in drinks such as beer, wine, and spirits as well as other products.
- **2.1.2.2.** Alcohol includes alcoholic beverages and alcoholic products as defined in the Utah Alcoholic Beverage Control Act, UTAH CODE ANN. § 32B-1-102.
- **2.1.2.3.** Alcohol includes beer, liquor, and any product that contains at least 0.5% of alcohol by volume and is obtained by fermentation, infusion, decoction, brewing, distillation, or other process that uses liquid or combinations of liquids, whether drinkable or not, to create alcohol in an amount equal to or greater than 0.5% of alcohol by volume.

2.1.3. "Electronic Cigarette"

- **2.1.3.1.** This is a broad category meant to encompass anything used in relation to vaping.
- **2.1.3.2.** As defined in <u>UTAH CODE ANN. § 76-10-101</u>, it means any electronic oral device that provides an aerosol or a vapor of nicotine or other substance; and which simulates smoking through the use or inhalation of the device; a component of the device; and an accessory sold in the same package as the device. It includes any oral device that is composed of a heating element, battery, or electronic circuit; and is marketed, manufactured, distributed, or sold as and e-cigarette; an e-cigar; an e-pipe; or any other product name or descriptor if it meets the above definition.
- **2.1.3.3.** It includes an "electronic cigarette product," as defined in <u>UTAH CODE ANN. §</u> 76-10-101;
- **2.1.3.4.** It includes an "electronic cigarette substance," as defined in 176-10-101, which is any substance, including liquid containing nicotine, used or intended for use in an electronic cigarette;
- 2.1.3.5. It includes a "flavored electronic cigarette product," as used in UTAH CODE ANN. § 76-10-101, which is an electronic cigarette product that has a taste or smell that is distinguishable by an ordinary consumer either before or during use or consumption of the electronic cigarette product, including a taste or smell of any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb, or spice;
- **2.1.3.6.** It includes a "prefilled electronic cigarette," as used in UTAH CODE ANN. § 76-10-101, which means an electronic cigarette that is sold prefilled with an electronic cigarette substance;

2.1.4. Illegal Drugs

- **2.1.4.1.** These are drugs that state or federal law prohibits a person from using, possessing, or distributing.
- **2.1.4.2.** Drugs are defined in the <u>Utah Controlled Substances Act, Utah Code Ann., Section 58-37-2</u>, as substances intended to affect the structure or any function of the body.
- 2.1.4.3. As used in this policy, the term "drug" or "drugs" includes all drugs and controlled substances as defined in Utah Code Ann. \sigma 58-37-2, including those listed in Schedules I through V of either the federal Substances Act or the Utah Controlled Substances Act.

2.1.5. Imitation and Other Harmful Substances

- **2.1.5.1.** This is a broad category intended to encompass harmful substances not otherwise defined in law or this policy.
- **2.1.5.2.** These include imitation controlled substances as defined in the <u>Utah Imitation Controlled Substances Act, Utah Code Ann., Section 58-37b-1 et seq.</u>
- **2.1.5.3.** These include psychotoxic chemical solvents as defined by <u>UTAH CODE ANN.</u>
- **2.1.5.4.** These include nitrous oxide as defined by <u>UTAH CODE ANN. § 76-10-107.5.</u>
- **2.1.5.5.** These include performance enhancing drugs.
- **2.1.5.6.** These include any other substance that when applied, ingested, injected, inhaled, or otherwise consumed with the intent to affect the structure or any function of the body; cause a condition of intoxication, elation, euphoria, dizziness, stupefaction, or dulling of the senses; or in any manner change, distort, or disturb the aural, visual, or mental processes.

2.1.6. Nicotine

- **2.1.6.1.** Nicotine, as defined in <u>UTAH CODE ANN. § 76-10-101</u>, is a poisonous, nitrogen-containing chemical that is made synthetically or derived from tobacco or other plants.
- 2.1.6.2. It includes an "alternative nicotine product," as defined in UTAH CODE ANN. 76-10-101, which is a product that contains nicotine, is intended for human consumption, is not purchased with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy, and includes pure nicotine, snortable nicotine, dissolvable salts, orbs, pellets, sticks, or strips, and nicotine-laced food and beverage.
- **2.1.6.3.** It includes a "nicotine product," as defined in UTAH CODE ANN. § 76-10-101.
- 2.1.6.4. It includes a "nontherapeutic nicotine device," as defined in <u>\$ 76-10-101</u>, which means a device that has a pressurized canister that is used to administer nicotine to the user through inhalation or intranasally, is not purchased with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy.

- **2.1.6.5.** It includes a "nontherapeutic nicotine device substance," as defined in <u>UTAH</u>
 <u>CODE ANN. § 76-10-101</u>, which means a substance that contains nicotine, is sold in a cartridge for use in a nontherapeutic nicotine device, is not purchased with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy.
- 2.1.6.6. It includes a "nontherapeutic nicotine product," as defined in UTAH CODE ANN.
 § 76-10-101, which means a nontherapeutic nicotine device, a nontherapeutic nicotine device substance, or a prefilled nontherapeutic nicotine device; and
- **2.1.6.7.** It includes a "prefilled nontherapeutic nicotine device," as defined in <u>UTAH</u>
 76-10-101, which means a nontherapeutic nicotine device that is sold prefilled with a nontherapeutic nicotine device substance.

2.1.7. Non-Addictive Prescription Drugs,

- **2.1.7.1.** These are drugs for which a prescription is required but which have a lower potential for abuse and a limited likelihood of leading to psychological or physical dependence.
- **2.1.7.2.** Drugs listed in Schedules IV and V of the state or federal <u>Controlled Substances Act</u> typically fall under this category.
- **2.1.7.3.** Examples include cough suppressants, antibiotics, diet drugs, non-amphetamine stimulants, long acting barbiturates, Valium, Lyrica, and other drugs not known to be addictive and which are not typically used recreationally.

2.1.8. Over-the-Counter Drugs

2.1.8.1. These are drugs that have a currently accepted medical use and for which a prescription is not needed.

2.1.9. Paraphernalia

- **2.1.9.1.** Paraphernalia refers to objects that have been or may be used in connection with a prohibited substance.
- **2.1.9.2.** As defined in the <u>Utah Drug Paraphernalia Act, UTAH CODE ANN. § 58-37a-3</u>, it includes any equipment, product, or material used or intended for use to store, contain, conceal, inject, ingest, inhale, or to otherwise introduce any prohibited substance into the human body.
- **2.1.9.3.** Notwithstanding this definition, students with written authorization from a parent or legal guardian and an appropriate health care provider may use and possess asthma inhalers, epinephrine auto-injectors (EpiPens), and equipment necessary for the administration of diabetes medication in accordance with Nebo School District Policy JHCD, Administering Medication to Students.

2.1.10. Tobacco

2.1.10.1. Tobacco is a product or substance made from a type of plant whose leaves have high levels of the chemical nicotine. The leaves are processed in various ways to create a substance that is smoked, applied to the gums, or inhaled.

- **2.1.10.2.** It includes a cigar, as defined in <u>Utah Code Ann. § 76-10-101</u>, which is a product that contains nicotine, is intended to be burned under ordinary conditions of use, and consists of any roll of tobacco wrapped in leaf tobacco, or in any substance containing tobacco, other than any roll of tobacco that is a cigarette as described below;
- 2.1.10.3. It includes a cigarette, as defined in Utah Code Ann. § 76-10-101, which is a product that contains nicotine, is intended to be burned under ordinary conditions of use, and consists of any roll of tobacco wrapped in paper or in any substance not containing tobacco, or any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of tobacco used in the filler, or its packaging and labeling, is likely to be offered to, or purchased by, consumers as a cigarette;
- 2.1.10.4. It includes tobacco paraphernalia as defined in UTAH CODE ANN. § 76-10-101, which is equipment, product, or material of any kind that is used, intended for use, or designed for use to package, repackage, store, contain, conceal, ingest, inhale, or otherwise introduce a tobacco product or an electronic cigarette substance into the human body, and includes the following:
 - Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes with or without screens, permanent screens, hashish heads, or punctured metal bowls:
 - · Water pipes;
 - Carburetion tubes and devices:
 - Smoking and carburetion masks;
 - Roach clips, meaning objects used to hold burning materials, such as a cigarette, that has become too small or too short to be held in the hand;
 - Chamber pipes;
 - Carburetor pipes;
 - Electric pipes;
 - Air-driven pipes;
 - Chillums;
 - Bongs; and
 - Ice pipes or chillers
 - **2.1.10.4.1.** "Tobacco paraphernalia" does not include matches or lighters.
- 2.2. It is not a violation of this policy for a student to possess, use, or be under the influence of a single dose or a dosage covering the period in which the student will be at school or at a school-sponsored activity of an over-the-counter drug or a prescription drug legally prescribed to the student. Any student to whom an over-the-counter or prescription drug is administered by the school must be in compliance with Nebo School District Policy JHCD, Administering

<u>Medication to Students</u>, and any student possessing an epinephrine auto-injector (EPI Pen) or prescription medication for asthma or diabetes must have all required forms completed and on file at the school. Failure to do so constitutes a violation of this policy.

3. PROHIBITED CONDUCT

Unless specifically authorized by subsection 2.2, no student may engage in any of the following conduct with a prohibited substance, as defined in section 2, while on school or District property, in a school bus or any other vehicle dispatched by the District, or at any school- or District-sponsored activity. These prohibitions apply whether or not the conduct occurs during regular school hours.

3.1. Distribute

- 3.1.1. A student may not give or lend a prohibited substance to another, even temporarily.
- 3.1.2. More specifically, as defined in the UTAH CODE ANN. § 58-37-1, et seq., and the <a href="Imitation Controlled Substances Act, UTAH CODE ANN. § 58-37b-1 et seq., the word distribute means deliver and includes the actual, constructive, or attempted transfer, delivery, or dispensing to another of any prohibited substance.
- **3.1.3.** Distribution encompasses the selling of a prohibited substance but does not require an exchange of money, goods, or services. Any sharing of a prohibited substance, whether in exchange for something of value or not, constitutes distribution and is prohibited by this policy.

3.2. Influence

- **3.2.1.** A student may not be under the influence of any prohibited substance.
- **3.2.2.** "Influence" means the effects of any prohibited substance identified or defined in this policy.
- **3.2.3.** A student is under the influence if the student has applied, inhaled, ingested, injected, or otherwise consumed a prohibited substance and is found on school or District property, including vehicles, or at a school- or District-sponsored event before effects of the substance have worn off.

3.3. Possession or Use

- **3.3.1.** A student may not possess or use any prohibited substance. In addition to the descriptions below, a student may be found in possession or use of a prohibited substance if it is on the student's person, in a bag or container under the control of the student, in the student's locker or vehicle, or near enough to a student that the student could touch it.
- **3.3.2.** As defined in <u>UTAH CODE ANN. § 58-37-2</u>, the terms *possession* and *use* both mean the joint or individual ownership, control, occupancy, holding, retaining, belonging, maintaining, or the application, inhalation, swallowing, injection, or consumption of a prohibited substances.
- **3.3.3.** *Possession* and *use* include individual, joint, or group possession or use of prohibited substances. For a student to be found to have possessed or used a prohibited substance, it is not required that the student be shown to have individually possessed, used, or controlled the substance, but it is sufficient if it is shown that the student jointly participated with one or more persons in the use, possession, or control of any prohibited substance with knowledge that the activity was occurring,

3.3.4. A student may be found to have possessed or used a prohibited substance if it is found in a place or under circumstances indicating that the student had the ability and the intent to exercise dominion and control over it.

3.4. Smoking

- **3.4.1.** A student may not smoke.
- **3.4.2.** As defined in <u>UTAH CODE ANN. § 76-10-101</u>, smoking means the possession of any lighted cigar, cigarette, pipe or other lighted smoking equipment. Therefore, a student may be found to have smoked whether the student inhaled or not.

3.5. Vaping

- **3.5.1.** A student may not vape.
- **3.5.2.** Vaping is not defined in Utah law. As used in this policy it means the use of an electronic cigarette or nicotine, as defined in subsection 2.1.

4. DISCIPLINARY ACTION

- **4.1.** Except as provided in paragraph 2.2, students are prohibited from using, possessing, being under the influence of, selling, or distributing the prohibited substances listed in subsection 2.1 and will be disciplined for any violation. Disciplinary action will be consistent with Nebo School District Policy JD, Student Conduct and Discipline and with the following provisions.
 - **4.1.1.** Administrators shall investigate reports, suspicion, and other evidence of violations of this policy in accordance with the procedures in Policy JD.
 - **4.1.2.** Students may be subject to suspension or expulsion for violation of this policy. School principals and assistant principals have the authority to suspend a student for up to ten (10) school days. The Superintendent or his/her designees may suspend a student for up to one (1) school year. The Board of Education may expel a student for a fixed or indefinite period of time.
 - 4.1.3. Administrators shall consult Exhibit 1 Recommended Disciplinary Actions for Violations of Policy JDB when considering appropriate restorative and disciplinary action for students found to have violated this policy. Administrators shall consider all facts surrounding the violation, including any mitigating or aggravating circumstances. Discipline shall be issued in accordance with the recommended actions listed in the exhibit unless an aggravating or mitigating circumstance exists, in which case an administrator may adjust the discipline accordingly. Principals and assistant principals are not authorized to suspend a student for more than ten (10) school days. Recommendations for a suspension beyond ten (10) school days must be made to the Coordinator of Student Services.
 - **4.1.3.1.** Mitigating circumstances may include the student's age and maturity, remorse, addiction, physical or mental illness or disability, role in the offense, personal or home circumstances, and willingness to seek help.
 - **4.1.3.2.** Aggravating circumstances may include the type and amount of the substance involved, the intent of the student, lack of remorse, violation of other policies in conjunction with the substance, influence on other students, and lack of cooperation with school officials.
 - **4.1.4.** A school employee who discovers a prohibited substance on school property or in the possession of a student shall immediately confiscate it and deliver it to the building administrator.

- 4.1.5. A school administrator shall dispose of or destroy an electronic cigarette product confiscated on school property or at a school-sponsored event. However, the administrator may release a confiscated electronic cigarette product to local law enforcement if the administrator has a reasonable suspicion that it contains an illegal substance and local law enforcement requests that it be released as part of an investigation or action.
- **4.1.6.** Administrators should refer to Section 10 of Nebo School District Policy JD, Student Conduct and Discipline and provide a continuum of intervention strategies such as school counseling services, parent/student conferences, behavior contracts, and drug treatment programs at every level of discipline for violations of this policy. Such intervention strategies should be in conjunction with the recommendations found in Exhibit 1 Recommended Disciplinary Actions for Violations of Policy JDB.
- **4.1.7.** Voluntary enrollment by students in drug testing, follow-up drug screenings, drug assessments, or drug treatment programs may be considered when imposing disciplinary action. Such enrollment is at the expense of the student.
 - **4.1.7.1.** A drug assessment is an intake evaluation at the Utah County Division of Substance Abuse/Assessment Center or an assessment of equal quality.
 - **4.1.7.2.** A drug test means the use of an oral fluid drug screen device, a blood screen, a hair follicle drug screen, or a urine drug screening method to determine use of specific prohibited illegal substances or alcohol. Nebo School District does not administer drug tests, nor does it discipline students based solely on the results of a drug test. Drug testing shall not be conducted by District employees. However, the District may contact law enforcement officials when students are suspected of having violated this policy, and the results of any testing conducted by law enforcement or other certified agency or individual may be considered in imposing student discipline.
 - **4.1.7.3.** "Drug Treatment" means a certified drug or alcohol treatment program.
 - **4.1.7.4.** "Follow-up Drug Screening" means a drug test voluntarily submitted to by a student during the period of a suspension or other discipline for violation of this policy and may be considered in a review of the discipline imposed. Follow-up drug screenings are not required and may not be conducted by District employees.
- 4.1.8. Students are encouraged to disclose the source of the prohibited substance for which they were found in violation, which means they should disclose to their administrator (1) the name of the person who provided the prohibited substance; (2) how the substance was provided; (3) where the substance was provided; and (4) when the substance was provided. Disclosing the source is strongly encouraged and may be considered when imposing discipline for a violation of this policy.
- **4.1.9.** Students are encouraged to refer themselves to a counselor or other school official for help complying with this policy. Self-referrals prior to being found in violation of this policy may be considered when imposing disciplinary action. The District will provide a conference with the school designated educator and/or the school intervention team staff to discuss possible resources for assistance.

5. RECORD OF VIOLATIONS

5.1. Policy violations are cumulative for grades K-12, and disciplinary action becomes more severe with each subsequent violation, regardless of whichever prohibited substance is the subject of the violation. For example, if a student whose record shows a first offense of the policy for

possession of tobacco in the eighth grade is found to have distributed alcohol in the ninth grade, the distribution of alcohol would constitute a second offense under Exhibit 1 – Recommended Disciplinary Actions for Violations of Policy JDB.

- **5.2.** The records of violations of student use, possession, being under the influence, sale, or distribution of prohibited substances shall note the date, type of violation, and disciplinary action taken and will be kept in the student's record.
- **5.3.** A record of similar violations from previous schools outside Nebo School District will be taken into account when imposing discipline for violations of this policy.

6. STUDENTS WITH DISABILITIES

6.1. Whenever a student receiving special education and related services under the Individuals with Disabilities Education Act (IDEA) or accommodations under Section 504 of the Rehabilitation Act of 1973 (Section 504) is subject to discipline for a violation of this or another District policy, the discipline due process procedures prescribed by applicable state and federal laws and regulations shall be followed. See Nebo School District Policy JD, Student Conduct and Discipline.

7. PREVENTION PROGRAM

7.1. In accordance with <u>UTAH CODE ANN. 53G-10-406</u> and <u>UTAH ADMIN. CODE R277-910</u>, schools shall offer the Underage Drinking and Substance Abuse Prevention Program each year to students in grade 4 or 5, grade 7 or 8, and grade 9 or 10.

1. PURPOSE AND PHILOSOPHY

The Board of Education of Nebo School District recognizes that every employee should have the opportunity to work in an environment that is safe, conducive to the educational goals of the District, and free from unnecessary disruption. The use, manufacture, possession, influence, distribution, dispensation, and sale of tobacco, alcohol, drugs, or other similarly harmful substances or drug paraphernalia in the workplace jeopardizes this safe environment and constitutes a hazard to the health and welfare of students and employees, in addition to being illegal under state and federal law. In order to maintain a secure and orderly learning environment, the District hereby adopts this policy to assist employees in avoiding the dangers of the Prohibited Substances outlined herein. It is the policy of Nebo School District under the Drug-Free Workplace Act of 1988, 41 USC 8101, et seq., 34 CFR 84.100, et seq., to adopt, implement, maintain, and enforce a drug- and alcohol-free workplace.

2. PROHIBITED SUBSTANCES

- 2.1. Unless specifically authorized by law, including the <u>Utah Medical Cannabis Act, UTAH CODE ANN. § 26-61a-101 et. seq.</u>, or paragraph 2.5, as a condition of employment no employee may use, manufacture, possess, be under the influence of, sell, dispense, or distribute any of the Prohibited Substances described in subsection 2.4 while on school or District property; in any bus or other vehicle dispatched by the District; at any activity trip, educational field trip, or overnight travel as those terms are defined in <u>Nebo School District Policy IICA Student Educational Travel</u>; or at any time while on duty, supervising students, or otherwise acting within the scope of employment. These prohibitions apply whether or not the actions occur during regular school hours.
- 2.2. For purposes of this policy, employees are considered to be on duty during the entirety of any activity trip, educational field trip, or overnight travel, regardless of location, time of day or night, or number of other individuals present or said to be supervising students. Employees travelling with students are never considered off duty. Likewise, employees travelling for District or school business under Nebo School District Policy DLC, Personnel Travel may not engage in behavior or activities that reflect negatively on the District or incur civil or criminal liability.
- 2.3. Specifically, individuals on personnel travel who may be operating a bus or other vehicle, whether personal, District, or owned by a third party, must abide by the prohibitions of this section. Moreover, the Utah Medical Cannabis Act is superseded by federal law related to commercial driver licenses (CDL) for bus drivers, and drivers' use of medical marijuana remains prohibited.
- **2.4.** The following are Prohibited Substances:

2.4.1. Addictive Prescription Drugs

- **2.4.1.1.** These are drugs for which a prescription is required and which have a high potential for abuse and may lead to severe or moderate psychological or physical dependence.
- **2.4.1.2.** All drugs listed in Schedule II of the federal <u>Controlled Substances Act</u>, and most from Schedule III, fall under this category. Examples include, but are not limited to, oxycodone (such as Percocet and OxyContin), Fentanyl, Morphine, hydrocodone/codeine (such as Lortab and Vicodin), and Paregoric.

2.4.2. Alcohol

- **2.4.2.1.** Alcohol is a chemical and a drug typically found in drinks such as beer, wine, and spirits as well as other products.
- **2.4.2.2.** Alcohol includes alcoholic beverages and alcoholic products as those terms are defined in the UTAH CODE ANN. § 32B-1-102.
- **2.4.2.3.** Alcohol includes beer, liquor, and any product that contains at least 0.5% of alcohol by volume and is obtained by fermentation, infusion, decoction, brewing, distillation, or other process that uses liquid or combinations of liquids, whether drinkable or not, to create alcohol in an amount equal to or greater than 0.5% of alcohol by volume.

2.4.3. Electronic Cigarette

- **2.4.3.1.** This is a broad category meant to encompass anything used in relation to vaping.
- 2.4.3.2. As defined in UTAH CODE ANN. \$ 76-10-101, it means: any electronic oral device that provides an aerosol or a vapor of nicotine or other substance; and which simulates smoking through its the use or through inhalation of the device; a component of the device described above; and an accessory sold in the same package as the device described above. It includes any oral device that is composed of a heating element, battery, or electronic circuit; and is marketed, manufactured, distributed, or sold as and e-cigarette; an e-cigar; an e-pipe; or any other product name or descriptor if it meets the above definition.
- **2.4.3.3.** It includes an "electronic cigarette product," as defined in <u>UTAH CODE ANN. §</u>
- 2.4.3.4. It includes an "electronic cigarette substance," as defined in UTAH CODE ANN. § 76-10-101, which is any substance, including liquid containing nicotine, used or intended for use in an electronic cigarette;
- 2.4.3.5. It includes a "flavored electronic cigarette product," as used in <u>\$ 76-10-101</u>, which is an electronic cigarette product that has a taste or smell that is distinguishable by an ordinary consumer either before or during use or consumption of the electronic cigarette product, including a taste or smell of any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb, or spice;
- 2.4.3.6. It includes a "prefilled electronic cigarette," as used in UTAH CODE ANN. § 76-10-101, which means an electronic cigarette that is sold prefilled with an electronic cigarette substance;

2.4.4. Illegal Drugs

- **2.4.4.1.** These are drugs that state or federal law prohibits a person from using, possessing, or distributing.
- **2.4.4.2.** Drugs are defined in the <u>Utah Controlled Substances Act, UTAH CODE ANN. §</u> 58-37-2, as substances intended to affect the structure or any function of the body.
- **2.4.4.3.** As used in this policy, the term "drug" or "drugs" includes all drugs and controlled substances as defined in Utah Code Ann. § 58-37-2, including those listed in Schedules I through V of both the federal Controlled Substances Act and the Utah Controlled Substances Act.

2.4.5. Imitation and Other Harmful Substances

- **2.4.5.1.** This is a broad category intended to encompass harmful substances not otherwise defined in law or this policy.
- **2.4.5.2.** These include imitation controlled substances as defined in the <u>Utah Imitation</u> Controlled Substances Act, UTAH CODE ANN. § 58-37b-1, et seq.
- **2.4.5.3.** These include psychotoxic chemical solvents as defined by <u>UTAH CODE ANN.</u> § 76-10-107.
- **2.4.5.4.** These include nitrous oxide as defined by UTAH CODE ANN. § 76-10-107.5
- **2.4.5.5.** These include performance enhancing drugs.
- **2.4.5.6.** These include any other substance that when applied, ingested, injected, inhaled, or otherwise consumed with the intent to affect the structure or any function of the body cause a condition of intoxication, elation, euphoria, dizziness, stupefaction, or dulling of the senses; or in any manner change, distort, or disturb the aural, visual, or mental processes.

2.4.6. Nicotine

- **2.4.6.1.** Nicotine, as defined in UTAH CODE ANN. § 76-10-101, is a poisonous, nitrogen-containing chemical that is made synthetically or derived from tobacco or other plants.
- 2.4.6.2. It includes an "alternative nicotine product," as defined in UTAH CODE ANN. 76-10-101, which is a product that contains nicotine, is intended for human consumption, is not purchased with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy, and includes pure nicotine, snortable nicotine, dissolvable salts, orbs, pellets, sticks, or strips, and nicotine-laced food and beverage;
- 2.4.6.3. It includes a "nicotine product," as defined in UTAH CODE ANN. § 76-10-101;
- 2.4.6.4. It includes a "nontherapeutic nicotine device," as defined in UTAH CODE ANN. 76-10-101, which means a device that has a pressurized canister that is used to administer nicotine to the user through inhalation or intranasally, is not purchased with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy;
- 2.4.6.5. It includes a "nontherapeutic nicotine device substance," as defined in UTAH
 76-10-101, which means a substance that contains nicotine, is sold in a cartridge for use in a nontherapeutic nicotine device, is not purchased

- with a prescription from a licensed physician, and is not approved by the United States Food and Drug Administration as nicotine replacement therapy;
- 2.4.6.6. It includes a "nontherapeutic nicotine product," as defined in <u>UTAH CODE ANN.</u>
 Mailto:\$\frac{\$76-10-101}{101}\$, which means a nontherapeutic nicotine device, a nontherapeutic nicotine device; and
- **2.4.6.7.** It includes a "prefilled nontherapeutic nicotine device," as defined in UTAH
 76-10-101, which means a nontherapeutic nicotine device that is sold prefilled with a nontherapeutic nicotine device substance.

2.4.7. Non-Addictive Prescription Drugs

- **2.4.7.1.** These are drugs for which a prescription is required but which have a lower potential for abuse and a limited likelihood of leading to psychological or physical dependence.
- **2.4.7.2.** Drugs listed in Schedules IV and V of the federal Controlled Substances Act fall under this category.
- **2.4.7.3.** Examples include cough suppressants, antibiotics, diet drugs, non-amphetamine stimulants, long acting barbiturates, Valium, Lyrica, and other drugs not known to be addictive and which are not typically used recreationally.

2.4.8. Over-the-Counter Drugs

2.4.8.1. These are drugs that have a currently accepted medical use and for which a prescription is not needed.

2.4.9. Paraphernalia

- **2.4.9.1.** Paraphernalia refers to objects that have been or may be used in connection with a prohibited substance.
- **2.4.9.2.** As defined in the <u>Utah Drug Paraphernalia Act, UTAH CODE ANN. § 58-37a-3</u>, it includes any equipment, product, or material used or intended for use to store, contain, conceal, inject, ingest, inhale, or to otherwise introduce any Prohibited Substance into the human body.
- **2.4.9.3.** Notwithstanding this provision, employees may use and possess asthma inhalers, epinephrine auto-injectors (EpiPens), and equipment necessary for the administration of diabetes medication.

2.4.10. Tobacco

- **2.4.10.1.** Tobacco is a product or substance made from a type of plant whose leaves have high levels of the chemical nicotine. The leaves are processed in various ways to create a substance that is smoked, applied to the gums, or inhaled.
- 2.4.10.2. It includes a cigar, as defined in <u>UTAH CODE ANN. § 76-10-101</u>, which is a product that contains nicotine, is intended to be burned under ordinary conditions of use, and consists of any roll of tobacco wrapped in leaf tobacco, or in any substance containing tobacco, other than any roll of tobacco that is a cigarette as described below;
- 2.4.10.3. It includes a cigarette, as defined in UTAH CODE ANN. § 76-10-101, which is a product that contains nicotine, is intended to be burned under ordinary conditions of use, and consists of any roll of tobacco wrapped in paper or in any substance not containing tobacco, or any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of

tobacco used in the filler, or its packaging and labeling, is likely to be offered to, or purchased by, consumers as a cigarette;

- **2.4.10.4.** It includes tobacco paraphernalia as defined in UTAH CODE ANN. \ 76-10-101, which is equipment, product, or material of any kind that is used, intended for use, or designed for use to package, repackage, store, contain, conceal, ingest, inhale, or otherwise introduce a tobacco product or an electronic cigarette substance into the human body, and includes the following:
 - 2.4.10.4.1. Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes with or without screens, permanent screens, hashish heads, or punctured metal bowls;
 - **2.4.10.4.2.** Water pipes;
 - **2.4.10.4.3.** Carburetion tubes and devices;
 - 2.4.10.4.4. Smoking and carburetion masks;
 - **2.4.10.4.5.** Roach clips, meaning objects used to hold burning materials, such as a cigarette, that has become too small or too short to be held in the hand;
 - **2.4.10.4.6.** Chamber pipes;
 - 2.4.10.4.7. Carburetor pipes;
 - 2.4.10.4.8. Electric pipes;
 - 2.4.10.4.9. Air-driven pipes;
 - 2.4.10.4.10. Chillums;
 - 2.4.10.4.11. Bongs; and
 - 2.4.10.4.12. Ice pipes or chillers.
- **2.4.10.5.** "Tobacco paraphernalia" does not include matches or lighters.
- 2.5. It is not a violation of this policy for an employee to possess, use, or be under the influence of an over-the-counter drug or a prescription drug legally prescribed to the employee, so long as the employee has not used more than the prescribed or recommended dosage or the effects of the drug do not interfere with the employee's ability to perform required job functions. It is also not a violation of this policy for an employee to distribute a single dose of an over-the-counter drug consistent with the drug's directions for use and all District policies, including Nebo School District Policy JHCD, Administering Medication to Students.

3. PROHIBITED CONDUCT

Unless specifically authorized by paragraph 2.5, no employee, volunteer, or visitor may engage in any of the following conduct with a prohibited substance while on school or District property, in any bus or other vehicle dispatched by the District, or at any school- or District-sponsored activity. These prohibitions apply whether or not the conduct occurs during regular school hours.

3.1. Distribute

- **3.1.1.** An employee may not give or lend a prohibited substance to another, even temporarily.
- 3.1.2. More specifically, as defined in the <u>Utah Controlled Substances Act, UTAH CODE ANN. § 58-37-1, et seq.</u>, and the <u>Imitation Controlled Substances Act, UTAH CODE ANN. § 58-</u>

- <u>37b-1 et seq.</u>, the word *distribute* means *deliver* and includes the actual, constructive, or attempted transfer, delivery, or dispensing to another of any prohibited substance.
- **3.1.3.** Distribution encompasses the selling of a prohibited substance but does not require an exchange of money, goods, or services. Any sharing of a prohibited substance, whether in exchange for something of value or not, constitutes distribution and is prohibited by this policy.

3.2. Influence

- **3.2.1.** An employee may not be under the influence of any prohibited substance in a way that impairs the employee, limits their ability to do their job, or interferes with the work of other employees or learning of students.
- **3.2.2.** *Influence* means the effects of any prohibited substance identified or defined in this policy.
- **3.2.3.** An employee is under the influence if the employee has applied, inhaled, ingested, injected, or otherwise consumed a prohibited substance and is found on school or District property, including vehicles, or at a school- or District-sponsored event, before effects of the substance have worn off.

3.3. Possession or Use

- **3.3.1.** An employee may not possess or use any prohibited substance. In addition to the descriptions below, an employee may be found in possession or use of a prohibited substance if it is on the employee's person, in a bag or container under the control of the employee, in the employee's vehicle, or near enough to the employee that the employee could touch it.
- **3.3.2.** As defined in <u>UTAH CODE ANN. § 58-37-2</u>, the terms *possession* and *use* both mean the joint or individual ownership, control, occupancy, holding, retaining, belonging, maintaining, or the application, inhalation, swallowing, injection, or consumption of a prohibited substances.
- **3.3.3.** Possession and use include individual, joint, or group possession or use of prohibited substances. For an employee to be found to have possessed or used a prohibited substance, it is not required that the employee be shown to have individually possessed, used, or controlled the substance, but it is sufficient if it is shown that the employee jointly participated with one or more persons in the use, possession, or control of any prohibited substance with knowledge that the activity was occurring,
- **3.3.4.** An employee may be found to have possessed or used a prohibited substance if it is found in a place or under circumstances indicating that the employee had the ability and the intent to exercise dominion and control over it.

3.4. Smoking

- **3.4.1.** An employee may not smoke while on duty.
- **3.4.2.** As defined in <u>UTAH CODE ANN. § 76-10-101</u>, smoking means the possession of any lighted cigar, cigarette, pipe or other lighted smoking equipment. Therefore, an employee may be found to have smoked whether the employee inhaled or not.

3.5. Vaping

- **3.5.1.** An employee may not vape while on duty.
- **3.5.2.** Vaping is not defined in Utah law. As used in this policy it means the use of an electronic cigarette or nicotine, as defined in subsections 2.4.3 or 2.4.6.

4. NOTIFICATION AND REPORTING

- **4.1.** Employees must notify the Director of Human Resources of any drug or alcohol related arrest within 48 hours of the arrest or as soon as possible consistent with <u>Nebo School District Policy GBN, Employment Background Checks</u> and <u>UTAH ADMIN. CODE, R277-316</u>.
- **4.2.** Employees must notify the Director of Human Resources of any criminal drug statute conviction for a violation occurring in the workplace no later than five (5) days after such conviction.
- **4.3.** The Director of Human Resources shall report drug or alcohol conviction, arrest, or offense information received from a licensed educator to the USOE within 48 hours of receipt of the information from the licensed educator.

5. EMPLOYEE DISCIPLINE

- **5.1.** Employees found in violation of this policy will be subject to disciplinary action, up to and including termination, consistent with Nebo School District Policy GCPD, Employee Discipline, Administrative Leave, and Orderly Termination, the applicable Employee handbook, and UTAH CODE ANN. § 53G-11-501, et seq.
- **5.2.** Investigation and Due Process
 - **5.2.1.** Upon being apprised of a possible violation of this policy, the administrator at the lowest appropriate level shall promptly and thoroughly investigate the alleged misconduct and document the findings.
 - **5.2.2.** Prior to taking any disciplinary action beyond a verbal directive/written summary, the District must, consistent with Nebo School District Policy GCPD, Employee Discipline, Administrative Leave, and Orderly Termination, provide career employees and provisional employees with minimal due process. Such due process includes notice of the accusation, evidence of the misconduct, and the opportunity to present the employee's side of the story to the supervisor. The notice and informal hearing must precede the imposition of disciplinary action.
- **5.3.** If a supervisor or administrator has reason to believe that an employee has committed a crime and may be under the influence of a Prohibited Substance, law enforcement should be contacted.
- **5.4.** An employee may be referred by the Director of Human Resources to a drug or alcohol counseling and rehabilitation program as part of the disciplinary action taken for violation of this policy.
 - **5.4.1.** In such cases the employee may be required to use sick or vacation leave, or may be granted administrative leave, for inpatient treatment. Continued discretion of the principal, supervisor or Director of Human Resources based on an evaluation of the employee's ability to perform adequately during this time is required. Employees undergoing rehabilitation must sign a release to allow the transmittal of verbal and/or written progress reports between the District and inpatient/outpatient provider. All such communication shall be classified as confidential information.
 - 5.4.2. An employee receiving outpatient treatment must complete such treatment on the employee's own time; however, reasonable accommodations should be made for treatment related to disability as defined under the <u>Americans with Disabilities Act (ADA)</u> and § 504 of the Rehabilitation Act of 1973 (§ 504).
 - **5.4.2.1.** Alcoholism may constitute a disability under the law, but accommodations may not permit an employee to use, possess, sell, or be under the influence of alcohol as prohibited by this policy, and all employees must maintain the ability to perform the essential functions of their jobs.

5.4.2.2. Likewise, a history of drug addiction may constitute a disability and require certain accommodations related to treatment. Nevertheless, current illegal drug use exempts an individual from protection under the ADA and Section 504.

Similarly, Salisbury Land, L.L.C. currently owns Lot 2 of Pine View, Plat A, Subdivision consisting of 16.20 acres of land, and upon the completion of the property transaction, will own Lot 1 of Pine View, Plat B, Subdivision consisting of 16.20 acres of land.

FURTHER RESOLVED that the Board of Education directs District legal counsel and administrative staff to complete the property transaction as soon as reasonably practicable subject to the satisfaction and resolution of the terms and conditions set forth in the Property Exchange Agreement attached hereto.
