5.1 PUBLIC HEARING - Request by Alani Fua for preliminary plan approval of the Pacen Hollow Subdivision, a four-lot subdivision on Utah County Parcel 08:155:0007 located at 294 North 800 East in the R-1-7.5, Residential Zone.

Staff Presentation:

Chris Van Aken stated this is a request for Preliminary Plan approval of a four-lot subdivision located at 294 North 800 East in the R-1-7.5 Zone. The parcel meets the parameters of that zone based on the lot layout. The total land area being divided is 1.12 acres. It lines up with the General Plan, and the underlying zone. If there are any other redlines, we will work with the applicant to address those and we will bring the final plat to you at a later date.
