Commissioner Stacey Eaton read a statement submitted by Jacob and Tirsa Stewart regarding fire safety on their property. Commissioner Shaun Huntsman referenced the City Code about the setback requirements of the flagged lot 10-19E-4. Commissioner Stacey Eaton commented to prohibit parking in ROW for Safety and Emergency vehicles, turn arounds, and stated his concerns of enforcement.

Georgia and Steve Carpenter commented their full support on necessary approvals for the Stewart property.

Chairman Joey Campbell read the fire recommendation regarding spacing requirements at hose ways, road widths, and turn around requirements. Alarm plans are acceptable. Staff Comments: Darrin needs clarification on 4,5,6 and 7. Development agreement is needed. Applicant is generally in compliance with this project. Approve with conditions of Planning Commission.

Commissioner Shaun Huntsman motioned to approve the Preliminary Site Plan Application for Settler Junction RV for approval to the City Council with conditions of, staff comments, subject to the new nightly rental code, trash enclosures being included in the construction drawings, and to get a dedicated access roadway encroachment from UDOT. Motion was seconded by Commissioner Val Preslar. Motion unanimously carried 5-0. Commission Vote: Val Preslar – aye, Stacey Eaton – aye, Gary Tomsik – aye, Joey Campbell – aye, Shaun Huntsman – aye.

G. DISCUSSION ITEM(S):

1. Discussion on 10-22 Sign Regulations.

The Commissioners discussed the sign ordinance and adding a policy to require special inspections. Remove from next meetings agenda.

2. Discussion on possible future Resort Zone Overlay.

The Commissioners discussed defining what the Resort Zone is by section, while updating the general plan with public input.

3. Discussion on nightly rentals/tiny homes

The Commissioners discussed the current code and how to word the exemption. Create a new code specifically for RV parks and modify nightly rental code.
