Uintah Transportation Special Service District (Owner) is requesting Bids for the construction of the following Project: UTSSD 2022 TIIMP – Pavement Repair

Bids for the construction of the Project will be received at the offices of the Uintah County Clerk Auditor, ATTN: Cheryl Meier, UTSSD located at 152 East 100 North, Vernal, UT 84078, until, May 25, 2022 at 4:00 PM local time. At that time, the Bids received will be publicly opened and read.

The Project includes the following Work: Approximately 27,000 square yards of pavement repair, soft spot subgrade excavation, and related work on approximately 38 miles of roadway within Uintah County. Bids will be received for single contract.

Owner anticipates that the Project's total bid price will be approximately \$1,980,000. The Project is expected to be completed by August 31, 2022.
