From the LCC EIS website: UDOT received 14,000+ public comments during the initial Draft EIS comment period and from the Draft EIS Revised Chapter 26 Section 4(f) & 6(f) Evaluation comment period. These comments were thorough and detailed, requiring UDOT to take the time necessary to conduct further evaluation and provide responses. UDOT anticipates that the Final EIS will be released this summer (2022). The Final EIS will identify a single preferred alternative to improve transportation in Little Cottonwood Canyon. Following a 30-day public review period after the release of the Final EIS, UDOT will identify the selected alternative for implementation in a separate Record of Decision (ROD) in the winter of 2022.
