There will be a decrease in dental rates. No rate increase for vision or life insurance. However, there will be a 12% increase in medical premiums for the 2022-2023 service period. Commissioner Wilson commented that inflation has put a lot of pressure on the County's budget as well as each of us individually out in the real world. A good benefit package is what entices individuals to want to work for the county. Commissioner Gil Conover made a motion to approve the County's medical, dental, and vision insurance renewal plan for July 1, 2022 to June 30, 2023. POLICIES AND PROCEDURES MANUAL ADOPTING JUNETEENTH AS A RECOGNIZED
HOLIDAY AND A BEREAVEMENT POLICY.

Personnel Director Mary Huntington requested approval for a Resolution amending the Emery County Personnel Policies and Procedures Manual adopting Juneteenth as a recognized holiday and also a bereavement policy. She explained that on March 24, 2022 Governor Spencer Cox signed a law officially recognizing June 19th (Juneteenth) as a Utah state holiday. Juneteenth, National Freedonm Day represents the end of slavery in the U.S. If June 19th falls on a Tuesday, Wednesday, Thursday or Friday it is recognized on the preceding Monday. If it falls on Saturday or Sunday then it is recognized on the following Monday.

Also, effective May 4, 2022 the State of Utah passed HB 449 making changes to bereavement leave. Bereavement leave with pay is available to all benefits eligible employees even if in their 6 month probationary period who suffer the loss of an immediate family member. This leave may be granted to make funeral arrangements, settle family affairs, attend the funeral or memorial service and for bereavement. With the exception of the bereavement leave described in title 7, Benefits & Compensation, the amount of leave granted is at the discretion of the elected official/department head based upon the employee's individual circumstances and the needs of the department. An employee may take up to 32 hours for immediate family members. If additional time is needed, an employee may request to use vacation leave (if 6 month probationary period is up. In the event of a family member's death while the employee is on vacation or sick leave, the employee's time off may be extended by the amount of funeral leave permitted by this policy. In accordance with State Law, an employee may take up to 3

work days of paid bereavement leave in circumstances regarding the end of employee's pregnancy by way of miscarriage of stillbirth. Also other conditions as explained in Title 7, Chapter E, Section 8, (f) (g). Commissioner Gil Conover made a motion to adopt Resolution 5-3-22 a resolution amending Title 7, Chapter E, Section 8 of the Emery County Personnel Policies and Procedures Manual. The motion was seconded by Commissioner Kent Wilson. The motion passed.
