DANENE JACKSON, FINANCE MANAGER – THE FINANCIAL STATEMENT PACKET INCLUDES THREE DIFFERENT STATEMENTS:

- \* BUDGET TO ACTUAL STATEMENT: FINANCIAL STATEMENT: EVERYTHING IS PRETTY MUCH UNDER BUDGET. THERE IS ONE FINAL PROPERTY TAX DISTRIBUTION THAT WILL COME IN MARCH BEFORE IT IS FINALIZED. THERE WAS AN ADDITIONAL \$68,000 THAT WAS CONTRIBUTED TO THE FUND BALANCE OF THE CAPITAL PROJECTS FUND. THE DISTRICT DOES HAVE A 10-YEAR CIP (CAPITAL IMPROVEMENT PLAN) PLAN THAT WILL GO TO. WE ARE EARLY IN THE YEAR THE BUDGET TO ACTUAL IS NOT AS RELEVANT. WE HAVE RECEIVED 44.5% OF THE ANNUAL FEES.
- \* BALANCE SHEET: IS ON TRACK. DISTRICT HAD POSITIVE CASH BALANCE IN ALL ITS FUNDS SO IT MEETS THE REQUIREMENTS OF STATE LAW.
- \* INCOME STATEMENT: I DON'T SEE ANY PROBLEMS.
