COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC HEARING:

Mayor McCormick stated this is the second public hearing for the Community Development Block Grant program. The public hearing is called to allow citizens to provide input concerning the project that was awarded under the 2022 Community Development Block Grant program. The city has amended it's Capital Investment Plan and decided to apply for funds to upgrade the Kamas sewer system. The Capital Investment Plan is available in the office if anyone wants a copy. Scott Kettle will be the project manager. The project was successful in the regional rating and ranking process and received a grant in the amount of \$170,251. The proposed sections of the sewer main that will be slip lined will be along 300 North from Main Street to 200 East, along 200 East from 300 North to approximately 50 North, and along 100 North from 200 East to 290 East.

The Mayor then opened the public hearing and there was no public comments. The Mayor closed the public hearing. (6:12 P.M.)

Mayor McCormick turned the time over to Scott Kettle.

Scott Kettle stated we received a grant to do this project. The application is due at the end of the month. Hopefully the project will be completed by the end of fall.

Councilor J. Blazzard asked if it's done manhole to manhole.

Scott Kettle explained the majority is done inside the pipe. There are a couple of areas that will need to be dug up.

Mayor McCormick explained these CDBG grants are very competitive. It's quite a process for rating and ranking these applications. The scores are very close. It's great for Kamas that we get these grants.

Councilor Bateman asked if this project will require any generators and cause noise issues.

Scott Kettle stated if one is used it won't be on for long and shouldn't disturb the residents. This is our biggest slip lining projects so far. It will increase the lifespan of the pipe.
