BEN STANLEY, COUNTY DEPUTY ATTORNEY – THE ISSUE HERE IS THAT THE ALLRED'S HAD PROVIDED SOME WATER SHARES FOR SOME GRAZING PURPOSES AT SOLDIER SUMMER AND WERE GETTING SOME SPECIAL ARRANGEMENTS BASED ON THAT. IN FACT, THIS ITEM IS VERY SIMILAR TO A WORK SESSION WE'LL HAVE LATER IN THE DAY TODAY THAT IS WORTH DISCUSSING AT THAT POINT AS WELL. MY UNDERSTANDING OF THE ISSUES HERE ARE THAT THE ALLRED'S SOLD THEIR SHARES, BUT A LOT OF THE FOLKS THAT LIVE UP THERE IN SOLDIER SUMMIT STILL APPRECIATE HAVING THE GRAZING OCCUR BECAUSE OF GREENBELT STATUS CONSIDERATIONS AND SO THE COMMUNITY IS SUPPORTIVE OF THEM TO CONTINUE TO HAVE WATER ACCESS. THEY WERE PAYING AT THE TIME FOR ELECTRICITY AND ALSO CONNECTION FEE AND BECAUSE OF THAT RELATIONSHIP AND BECAUSE OF THE CHANGES THAT HAVE OCCURRED THERE, WE HAVE BEEN DISCUSSING AS A BOARD WHETHER OR NOT IT MADE SENSE TO EXTEND SOME SPECIAL AGREEMENT GOING FORWARD OR TO HAVE THEM JUST PAY TRADITIONAL WATER RATES FOR THEIR WATER USAGE OR WHAT WOULD BE THE BEST APPROACH. ONE OF THE ISSUES THAT WAS DISCUSSED LAST MEETING IN AUGUST WAS THE PLAN OF OUR PUBLIC WORKS DEPARTMENT TO DO AN RFP FOR A WATER RIGHTS EXPERT, ATTORNEY OR AN ENGINEER THAT COULD SPEAK SPECIFICALLY TO WATER RIGHT CONSIDERATIONS. MY SUGGESTION WOULD BE TO CONTINUE THIS INDEFINITELY AND THEN READDRESS IT WHEN WE'VE PURSUED THAT RPF AND HAVE HAD AN **OPPORTUNITY TO GO THROUGH THAT ROUTE.**

WE RECEIVED NOTE LAST WEEK THAT WE HAVE BEEN APPROVED FOR THOSE STATE MATCHING GRANT DOLLARS. IT WILL BE UP TO \$1.5 MILLION WITH A MATCH AND WE HAD PRE-APPROVED THE ARPA FUNDING COUNTYWIDE FOR THAT MATCH EARLIER ON. BEN STANLEY, COUNTY DEPUTY ATTORNEY – THIS ITEM IS SORT OF RELATED TO THE ALLRED ISSUES. IN THE PAST SOLDIER SUMMIT PEOPLE THAT HAVE CONTRIBUTED WATER SHARES IN VARIOUS WAYS TO THE WELLS AND THE WATER NEEDS AND THEN SOUGHT SOME PREFERENTIAL PRICING RELATED TO THAT. THE IDEA HERE IS THAT THE LAST I HAD HEARD FROM BRADY CHRISTENSEN (PUBLIC WORKS), IS THAT HAD ABOUT 85 OF THE 100 SHARES NEEDED FOR THE SECOND WELL, SO THERE'S STILL SOME WATER SHARES THAT WE COULD USE. THERE IS A MEMBER OF THE PUBLIC WHO WOULD LIKE TO PROPOSE THE POSSIBILITY OF MAYBE CONTRIBUTING TO THAT NEED FOR WATER SHARE AND THEN EXPLORE WITH THE BOARD WHAT KIND OF POSSIBLE ARRANGEMENTS MIGHT BE WORKED OUT. I WILL TURN THE TIME OVER TO MR. ROBERT BAIRD. ROBERT BAIRD, SOLDIER SUMMIT PROPERTY OWNER – I HAVE BEEN WORKING ON THIS FOR ABOUT A YEAR. I ACTUALLY GOT AN EMAIL FROM BEN (STANLEY) WITH REGARD OF SOME CONCERN ABOUT ME USING TOO MUCH WATER. IN THE LAST YEAR I'VE BEEN ABLE TO ACQUIRE 2 WATER SHARES AND I'VE WORKED WITH THE STATE ENGINEERS AND THESE 2 SHARES HAVE BEEN ASSIGNED TO THE EXISTING WELL AT SOLDIER SUMMIT. THERE'S TWO-ACRE SHARES WHICH IS EQUIVALENT TO 650,000 GALLONS A YEAR.

IT IS NOT FEASIBLE FOR ME TO DIG MY OWN WELL SO AS I REACHED OUT TO BRADY (CHRISTENSEN) TO SEE IF THERE WAS SOME WAY WE COULD WORK TOGETHER, THE THOUGHT WAS THAT I COULD CONTRIBUTE THESE TWO SHARES SO SOLDIER SUMMIT AND JUST LIKE HAS BEEN DONE WITH THE ALLRED'S, JUST PAY EITHER AN ELECTRICITY FEE OR WHATEVER THE BOARD THINKS IS APPROPRIATE. IN THE PAST YEAR I THINK I'VE USED 260,000 GALLONS OF WATER.

ROBERT BAIRD, BEN STANLEY, DANENE JACKSON, RICHARD NIELSON, AND BOARD MEMBERS DISCUSSED DIFFERENT OPTIONS, CONDITIONS, FLEXIBILITY, SYSTEM ANALYSIS, HOA, CONTRIBUTION VS. USAGE RATIO, DIFFERENCES WITH ALLRED'S, ETC.

JAMES MCCLURE – THERE ARE CC&R'S (COVENANTS, CONDITIONS & RESTRICTIONS) IN PLACE FOR BOTH THE HOME, BOARD AND THE CONSERVANCY DISTRICT ON HOW MUCH WATER CAN BE USED BY EACH HOOKUP PER MONTH.
