Please be informed that the San Juan School District Board of Education will hold its next board meeting on **June 22, 2022** via **Virtual and In-person PUBLIC MEETING**. Meeting link can be found on the district website www.sjsd.org. The opening of the meeting, Board Work Session and approval of the agenda is scheduled for **3:00 p.m.** A Closed Session may be held as needed.

Public Comments and Consent Agenda items are scheduled to begin at 6:00 p.m.

Pursuant to the responsibilities and commitments in San Juan School District's Native American Policy and Procedures, the **PUBLIC HEARING for the Activities and Participation data as well as Questions and Responses addressing from stakeholders specific to Native American Education will be held on June 22, 2022 during the School Board Meeting, with Public Comment included at 6:00 p.m.**

PUBLIC HEARING and Comment Session regarding the Fiscal Year 2021-22 revised budget and the Fiscal Year 2022-23 proposed budget will be held starting at 6:20 pm. If necessary, the regular board meeting will be suspended to complete the Budget Hearing, and will reconvene once the Budget Hearing is adjourned. Following the public hearing, the board will consider budget adoption and other action items as indicated on the published agenda.

PUBLIC HEARING and Comment Session regarding the Responsible Use of Technology Agreement for Students will begin at 6:10 pm. Public is invited to comment regarding the proposed agreements for Elementary and Secondary Schools which outline the expectations between students, parents/guardians and the district regarding the use of electronic devices or privately-owned devices on the school network.
