The American Fork City Council met in a regular session on Tuesday, May 24, 2022, in the American Fork City Hall, 31 North Church Street, commencing at 7:00 p.m.

REGULAR SESSION

1. Pledge of Allegiance; Invocation by Council Member Hunter; roll call.

Mayor Frost welcomed everyone to the meeting. Those present recited the Pledge of Allegiance and an invocation was offered by Council Member Hunter. Roll Call was taken, and Council Member Carroll was excused.

2. Presentation of the HERO Award to the American Fork High State Champions.

Mayor Frost invited Sarah Beeson and Principal Peter Glahn to the front, along with students from American Fork High School, to present them with the HERO Award for earning various state championships this year. Principal Glahn stated this has been a wonderful year and they have seen more success than ever before. This is a school award, not just for the students. He was honored to accept the award on behalf of the school. He was grateful for the community's support and noted the coaches, directors, leaders, and fans were amazing.

3. <u>Presentation of awards from the Utah Recreation and Parks Association to the American</u> <u>Fork City Recreation department and Senior Center.</u>

Bronco Hunter, past president of the Utah Parks and Recreation Association was in attendance to present the Innovation of the Year Award to the Senior Center. Mr. Hunter stated the Senior Center worked hard during COVID to find ways to continue serving the members of the community, serving over 300 seniors a day. Stan Street, Senior Center Director, accepted the award and stated it was a pleasure to work at the Senior Center and thanked the crew and volunteers for all their hard work.

Mr. Hunter then recognized Doug Schneider, who was not in attendance, and presented the Lifetime Achievement Award for Mr. Schneider. Derric Rykert, Recreation Director, accepted on his behalf.

Mr. Hunter also presented the Lifetime Achievement Award to the family of Janet Oles, who passed away in 2021. Ms. Oles was one of the founding coaches of the Hilltop Aquatic Swim Team and loved each swimmer she worked with. It was noted that Ms. Oles was the foundation for the success of the program. Ms. Oles family was present to accept the award.

4. <u>Twenty-minute public comment period - limited to two minutes per person.</u> There were no public comments.

5. <u>City Administrator's Report</u>

David Bunker congratulated the American Fork High School Students for their state championships, as well as the Class of 2022.

6. Council Reports

Council Member Hunter reported they had the library children's expansion ribbon cutting last night. This expansion, which was possible due to PARC Tax funds and private donations, was a wonderful space for the library and would be a fantastic area.

Council Member Shelton noted that it took hours of dedication for the successes of the high school students, and it was nice to be able to celebrate their successes. He reported the Beautification Committee was beginning to look for Yards of the Month and the Steel Days Garden Tour. They were also looking for feedback on the recent city cleanup and hoped to make it an annual event.

5. Review and action on an ordinance repealing Section 17.1.300 of the American Fork City

Code related to zoning of annexed territories and adopting Chapter 17.20 relating to

annexation policies and procedures.

Cherylyn Egner explained this ordinance would repeal the section about zoning designations of the annexed territory and adopt the chapter outlining annexation policies and procedures. She noted the section repealed was addressed in the new chapter. American Fork City has previously annexed property under Section 418 of the state code but was now moving to petition based annexations. In preparing these policies and procedures, staff looked at surrounding cities and found that most do not allow annexations that creates or leaves behind an island or peninsulas. This ordinance adopting the policies and procedures for annexing follows state code, which does allow for unincorporated islands if the city and the county agree to the annexation. Ms. Egner noted the city was not prohibiting any annexations that leave behind an island or peninsula and this way would not require all parcels of an unincorporated island to be included in the annexation.

Council Member Hunter moved to adopt Ordinance No. 2022-05-22 repealing Section 17.1.300 of the city code and adopting Chapter 17.20 titled "Annexation Policies and Procedures." Council Member Taylor seconded the motion. Voting was as follows:

This was broken down into two parts: allowing for adjustments to the width of the road and for the components within the roadway.
