1. Welcome & Introductions - Representative Steve Handy & Senator Gene Davis

- a. Opening remarks Representative Handy
- b. Roll call attendance

 Motion to accept Gina Cornia. Roll Call Vote: All in attendance in favor.

2. Quick Updates

5 Min.

- a. Administrative Calli Forsyth, Utah Department of Ag & Food
 - Conflict of interest forms yearly conflict of interest forms. Need someone 18 years of age or older to watch members sign conflict of interest forms.
 - Seeking reimbursement for incurred expenses email to voting members, they need to fill out human resources form for reimbursements
 - iii. Two new member spots are open. Moving to 15 voting members.
- b. Local Food Purchase Assistance Cooperative Agreement Program Natalie Loots, Utah Department of Health. Natalie was not in attendance so Laura Holtrop Kohl presented.
 - Working on an application for a non-competitive USDA Grant for disadvantaged local farmers to connect them to disadvantaged communities. The state has allocated 2.2 million. 40% of those funds are reserved for Utah tribes.
 - Qualifying projects need to have a 51% minimum spent on food
 - Need help identifying disadvantaged farmers. Will need to work on a definition of disadvantaged farmers
 - Want to create RFA in 2023

3. 2022 Legislative Session Review

ii. Farm To School Appropriation

Senator Davis:

 Did not pass legislation. Most didn't understand what was being done with Farm to School. Needed representation and education from a spokesperson, Calli Forsyth proposed a retreat to educate legislators. Garrick Hall proposed maybe talking about it at Interim.

iii. Food Hub Appropriation

Senator Davis:

- Did not pass. The same issue of misunderstanding. The legislature seemed to be confused as to what the Food Hub does that is different from the Farm Bureau or Food Bank.

Senator Davis:

 Did not pass. The same issue of misunderstanding. Kelsey Hall and Gina Cornia said they are working to get better organization and better transparency.

v. Various Water Bills

4. LFAC Member Survey Results Review - Calli Forsyth, UDAF 10 Min.

Calli Forsyth: Survey was completed by 10 of the voting and non-voting members. Need more participation. The focus is on increasing the Local Food Advisory Council community. More minority community representation, more hands-on with producers and distributors. The survey was a short 8-question survey. All the answers were on par with what was talked about by Senator Davis, Representative Handy, Linda Gillmor, and Calli Forsyth. Ideas from survey answers:

- -Stronger connection with farmers and producers
- -Ideas for forming forums
- -More engagement from council members and elected officials
- -Set Tangible goals

- -Pulling in public to meetings
- -Reducing the time between the October meeting and the April meeting
- -Paid ads for LFAC
- -Establish Local Food Advisories in counties
- -Be more unified

5. New LFAC Structure Review - Senator Davis

Gina Cornia said that having the virtual option as well as the in-person would be nice in case people get sick or can't travel. Laura Kohl said that having it virtual has opened it up to rural Utah people that want to attend.

Senator Davis:

Senator Davis agrees that this is a good idea. Davis wants diversity on sub-committees. Looking into the option for sub-committees to be virtual. Will go through a list of people who have opted-in to serve as sub-committee chairs. Calli Forsyth says she would like to know what groups should be brought in to diversify the council. She has tried to get in contact with tribes from Utah. International Rescue, Hispanic Chamber, and Spice Kitchen were also brought up. Next meeting in June chairs will have chosen members of sub-committees. First presentations in August meeting.

6. National Food Policy/Advisory Council Best Practices - Kelsey Hall, Utah State University

See the attached presentation that was reviewed during the LFAC meeting. Kelsey Hall presented best practices for the Local Food Advisory Council. Other states' data was very helpful in the findings. Michigan, Iowa, North Carolina, South Carolina, and Colorado were analyzed and interviewed. Conducted phone interviews and found best practices from these states.

Kelsey Hall said we need to evaluate and measure the council's impact.
