

# Emery County Fire Protection District Meeting

Ignacio called the meeting to order.

1. **Approval of minutes for May 2022 meeting.** Stoney made a motion to approve the minutes for May 2022, Chase seconded the motion, motion approved unanimously.
2. **UFRA comments and business.** Nobody present
3. **Where is the next regional fire school? April 21st & 22nd** Ignacio asking for any volunteers to host. Ben (Green River) offered and it was determined the next location for 2023 Regional Fire School to be held in Green River.

Mark said he will get the pricing to Ignacio by Monday. Contract right now is at \$1,557,000.00 through the CIB.
