The Board reviewed R156-72 to see if any rules, other than R156-72-503(6), need to be revised. Mr. Marx reviewed rules that were recently changed due to legislative changes and previous Board meetings.

Mr. Marx answered questions from Ms. Bates regarding third party insurance, which is in statute (58-72-601) not rule.
