LEGISLATIVE LAND USE APPLICATION(S)

OAM2021-000493 - An Ordinance of the Salt Lake County Council Amending Section 19.04.462 of the Salt Lake County Code to include Wedding and Reception Uses in the definition of Restaurant, Liquor License; and to Enact Related Regulations. **Presenter:** Melissa Anderson (Motion/Voting)

The Planning Commission will act on the proposed ordinance amendment after taking comments from the public during their respective public hearings. Public comments will be provided pursuant to the planning commission's rules of conduct. Public comments will be limited to three minutes per person. The public is also invited to review and inspect the proposed ordinances at https://www.utah.gov/pmn/index.html under the Planning Commission's agenda.

Greater Salt Lake Municipal Services District Planning Manager Melissa Anderson provided an analysis of the staff report.

Commissioner Cohen said a restaurant with a liquor license is not the only facility that has weddings and outdoor weddings that can hold functions like this. Doesn't know if adding to restaurants is sufficient. Ms. Anderson said this pertains to gatherings at the facility, reception at the restaurant, and that an outdoor patio is included. Commissioner Palmer said this is extending what a restaurant allows and other zones allow wedding and reception uses. Ms. Anderson said these uses may be ongoing now at restaurants, but ordinance doesn't explicitly say these uses are allowed at the restaurant; this ordinance change clarifies they are allowed.

Commissioner Reid motioned to open the public hearing, Commissioner Hutchings seconded that motion. Commissioners voted unanimous in favor.

Comments: Mr. Marshall said based on the staff report and presentation and comments made so far, appears to be non-confrontational. Thanks to the special exception granted last month. Commissioner Omer motioned to close the public hearing, Commissioner Despain seconded that motion. Commissioners voted unanimous in favor.
