## White City Financial Report

**Dave Sanderson**, Financial Manager, reviewed the White City Metro Township administrative budget stating that 50% of the year has gone by. The American Rescue Plan (ARPA) funds need to be spent by 2024.

Council Member Perry, seconded by Council Member Price, moved to accept the White City Metro Township financial report. The motion passed unanimously.



## Unified Fire Authority

**Captain Ken Aldridge** updated the Council on the progress of various fire stations that are under construction. The wildland hand crew completed a 14-day assignment and were then dispatched to Idaho. The fuels crew helped with chipping services and have provided personnel for fire suppression. Retired fire fighter Alex Kluger was killed in a motorcycle accident on August 3, 2022. Sandy City Fire sent its fire report, and they are committed to increasing its staffing to a three-person crew.



### Unified Police Department

**Detective Jeff Fenton** stated high crimes in White City are vehicle burglaries. On Wednesday the motors unit is getting together to do traffic enforcement. The Community Police Academy registration is opening soon. The academy is 12 weeks and is usually held on Tuesday's from 6:00 p.m. – 10:00 p.m.

**Chief Randy Thomas** stated Unified Police Department (UPD) and Canyons School District have been discussing school shootings, gang violence and other types of incidents. Officers have gone through active shooter training. Once the new schools in Canyons School District are up and running, officers will tour those schools to become familiar with the layouts. Bus drivers and crossing guards are needed throughout the school district.

**Leonard Peterson** stated he has concerns about reports of a sexual predator living in the neighborhood near the school.

Utah League of Cities and Towns Membership

Rori Andreason stated the Utah League of Cities and Towns (ULCT) has made the determination that Metro Townships are allowed to join the organization. ULCT lobbies for cities and has a lot of influence in the legislature. It offers trainings, resources, and represents its member entities well. The cost for White City Metro Township to join is \$2,959.92 and is due on September 1, 2022.

Council Member Perry, seconded by Council Member Price, moved to approve the allocation of \$2,959.92 to join the Utah League of Cities and Towns. The motion passed unanimously.

### Salt Lake County Justice Courts

Paul Ashton stated the metro townships receive justice court services through an interlocal agreement with the Greater Salt Lake Municipal Services District (MSD) and Salt Lake County. The Salt Lake County Council notified the Justice Courts of its intent to dissolve the courts. If the Council wants to look elsewhere for justice court services, it will need to notify the MSD and Salt Lake County that it wants to modify the interlocal agreement.

Council Member Little stated it may make sense to look into contracting with Sandy City Justice Courts.

Council Member Perry stated initiating the letter will open the discussion and start the process of finding justice court services.

Council Member Cardenaz, seconded by Council Member Price, moved to approve the process of sending a letter to continue discussions on justice court services. The motion passed unanimously.

# Council Reports

Greater Salt Lake Municipal Services District (MSD)

Mayor Flint stated the MSD Board is reviewing department budgets.

Unified Police Department (UPD)

Mayor Flint stated UPD held a workshop with legislators, Kem Gardner Institute, and Zions Bank. There were discussions on taxing, philosophy, and working together.

Unified Fire Authority (UFA) & Unified Fire Service Area (UFSA)

Council Member Perry read a letter from Mayor Zoltanski discussing Sandy City Fire crews and increasing the number of individuals on a crew. Staffing will increase to three individuals as of July. UFA will hold a public hearing for the amended fee schedule on August 16. 2022. UFA is hoping to have 30 new recruits ready for camp at the beginning of next year.

South Salt Lake Valley Mosquito Abatement District

Council Member Price stated a case of West Nile Virus has been detected in Utah.

Wasatch Front Waste and Recycling District (WFWRD)

Council Member Cardenaz stated there was not a meeting in July. The 2023 budget will be discussed in upcoming meetings. WFWRD has updated its website to make it more user friendly.

Renee Plant, Administrative Manager, WFWRD, stated the new website was launched but had some errors that have since been fixed. Scheduling for reservations is working.

Mayor Flint stated when reserving a dumpster, the website is showing that all the dates are full.

Ms. Plant stated postcards to reserve a dumpster will be mailed on August 19, 2022. Individuals will be able to reserve a dumpster three business days after the postcard is mailed. Dumpsters will be available to reserve from September 21 - 23, 2022. She will confirm what date the reservations will open and let the Council know.

Salt Lake County Animal Services

Council Member Little stated most of the meeting was about fundraising and awards that animal services are getting. He has a concern with the accessibility of getting animals into the shelter for services they offer. He tried to make an appointment for his animal, but appointments were booked for the rest of the year. He emailed animal services, and they instructed him to try the Humane Society. In the past, animal services has been able to handle the regular needs of citizens. If animal services offers a service, it should be able to provide it.
