RESOLUTION NO. R2022-____

A RESOLUTION OF THE SOUTH SALT LAKE CITY COUNCIL AUTHORIZING THE SOUTH SALT LAKE POLICE DEPARTMENT TO APPROPRIATE FIREARMS, FIREARM PARTS, ACCESSORIES AND AMMUNITION IN ITS POSSESSION TO A PUBLIC INTEREST USE.

WHEREAS, the South Salt Lake City Police Department (SSLC PD) has acquired possession of firearms and ammunition as found property, as evidence of a crime, or for safekeeping, the lists of which are attached hereto as Exhibits A, B and C;

WHEREAS, the SSLC PD is authorized pursuant to state law to dispose of property after reasonable steps have been taken to determine the identity and location of the owner and reasonable steps have been taken to notify the owner that the property is in the SSLC PD's possession;

WHEREAS, the SSLC PD has made reasonable efforts to identify and notify owners of the property, and has either been unsuccessful in determining ownership over the property, has notified the apparent owner and has not received a timely response, or in the case of evidence has received confirmation from the prosecutor that the property is no longer needed as evidence;

WHEREAS, Utah Code permits the City Council to authorize that the lost or mislaid property, or evidence of a crime, be applied to a public interest use;

WHEREAS, the City has published notice, the Public Notice of which is attached hereto as Exhibit D, of the potential appropriation of this property, and has provided adequate time for the public to respond to this notice;

WHEREAS, where applicable, the prosecuting entities have affirmed that the items are no longer needed as evidence;

WHEREAS, the City Council finds that certain firearms, firearm parts, accessories and ammunition, listed in Exhibit A, could be put to beneficial public use through giving the items to the Bureau of Forensic Services;

WHEREAS, Salt Lake Wholesale Sports is a federally licensed firearms dealer with a state contract for the sale and purchase of firearms and law enforcement equipment;

WHEREAS, the City Council finds that certain firearms, firearm parts, accessories and ammunition, listed in Exhibit B, could be put to beneficial public use through selling the items to purchase public safety equipment; and

WHEREAS, the City Council finds that certain firearms, firearm parts, accessories and ammunition, listed in Exhibit C, previously approved for appropriation, to be provided to the

Bureau of Forensic Services should now be provided to Salt Lake Wholesale Sports to go towards the purchase of public safety equipment,

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of South Salt Lake that, pursuant to Utah Code Ann. §§ 77-24a-5, 24-3-103.5, and 24-3-103, the property identified on the lists accompanying this resolution may be appropriated for public interest use through providing the firearms, firearm parts, accessories and ammunition listed in and attached hereto as Exhibit A to the Bureau of Forensic Services and the firearms, firearm parts, accessories and ammunition listed in and attached hereto as Exhibits B and C, to Salt Lake Wholesale Sports for the purchase of public safety equipment.
