

NOTICE OF PUBLIC HEARINGS

SALT LAKE COUNTY AND MOUNTAINOUS PLANNING DISTRICT PLANNING COMMISSIONS

NOTICE IS HEREBY GIVEN Pursuant to Utah Code Title 17, Chapter 27a, Section 205, that the Salt Lake County Planning Commission will hold a public hearing on Wednesday, October 12 at 8:30 AM, and the Mountainous Planning District Planning Commission will hold a public hearing on Thursday October 6 at 3:00 PM. The purpose of these hearings is to receive public comment regarding a proposed land use ordinance:

OAM2022-000697 - AN ORDINANCE OF THE SALT LAKE COUNTY COUNCIL ENACTING CHAPTER 19.73 OF THE SALT LAKE COUNTY CODE ENTITLED FLOOD DAMAGE PREVENTION TO MAKE REGULATIONS IN THE UNINCORPORATED COUNTY OUTSIDE OF A MIGRATORY BIRD PRODUCTION AREA CONSISTENT WITH FEMA REGULATIONS; AMENDING SECTION 19.74.040 ENTITLED AREAS OF SPECIAL FLOOD HAZARD TO CLARIFY THAT CHAPTER 19.74 IS ONLY APPLICABLE TO MIGRATORY BIRD PRODUCTION AREAS; AND ENACTING RELATED REGULATIONS.

Public comments will be provided pursuant to the Planning Commissions' rules of conduct. Public comments will be limited to three minutes per person.
