WATER A report on the water situation was given by Tamera Martinson.

Precipitation for December was 3.9 inches and 2.01 inches month-to-date.

The Ogden River Water Users' Association had 11,757 acre feet of

storage water in the reservoir at the end of December.

UASD James Hill made a motion to appoint Tamera Martinson as the district's

representative to the Utah Association of Special Districts and to have Benjamin Quick serve as an alternate. He also motioned to approve and pay the dues for 2022. The motion was seconded by Paul Nelson. David Humphreys, Paul Nelson, James Hill, David Hall and Marci Doolan

passed the motion with an affirmative vote.

PETITIONS	There was one petition for inclusion (petition #3540) presented to the Board. David Hall made a motion to include petition #3540 into the district. Paul Nelson seconded the motion.
