AN ORDINANCE TO VACATE PUBLIC STREETS LOCATED IN THE WALLSBURG CEMETERY AND/OR WALLSBURG CEMETERY EXPANSION AREA

WHEREAS, Utah Code § 10-9a-609.5 authorizes a town council to vacate public streets or portions of public streets by ordinance; and

WHEREAS, Wallsburg Town desires to vacate portions of several streets located within the Wallsburg Cemetery and/or Wallsburg Cemetery expansion area; and

WHEREAS, Wallsburg Town submitted a Petition to Vacate and the Wallsburg Town Council held a public hearing on the Petition on September 1, 2022; and

WHEREAS, based on the Petition and public hearing, the Wallsburg Town Council has determined that good cause exists for the vacation and that neither the public interest nor any person would be materially injured by the vacation;

WHEREAS, the Wallsburg Town Council now desires to adopt this ordinance granting Wallsburg Town's Petition to Vacate.

NOW, THEREFORE, be it ordained by the Town Council of Wallsburg, Utah, as follows:

The following described public street is hereby vacated and will remain in the Town's name:

Beginning at the Northwest Corner of Lot 4 Block 24; North to the Southwest Corner of Lot 1 Block 33; East to the Southeast Corner of Lot 1 Block 33; North to the Northeast Corner of Lot 1 Block 33; East to the Northwest Corner of Lot 2 Block 34; South to the Southwest Corner of Lot 2 Block 34; East to the Southeast Corner of Lot 1 Block 34; South to the Northeast Corner of Lot 4 Block 23; West to the Northwest Corner of Lot 4 Block 24.

The following described public street is hereby vacated and will be deeded to

_____:

Beginning at the Northeast Corner of Lot 3 Block 24; West to the Northwest corner of Lot 3 Block 24; North to the Southwest Corner of Lot 2 Block 33; East to the Southeast Corner of Lot 2 Block 33; South to the Northeast Corner of Lot 3 Block 24.

This Ordinance shall take effect immediately upon publication as required by law.
