11. Discuss old F350 mini pumpers insurance and titles

We went over titles and discussions about selling off old trucks and equipment that is no longer being used; we have too many assets, which will hurt our chances of applying for grant money.

12. Discuss old and unknown titles to take off our insurance

Sams, as above, need to get insurance off the trucks we are getting rid of and selling to cities and/or nearby fire stations. Cut down on the cost of insurance.

13. This a reminder of the Beckers Fire apparatus we are selling and not keeping.

Asked the Chiefs to decide on what they wanted to keep or get rid of to lower the assets. Even scrap for metal to get ready for the new Fire Trucks.

14. Fire Truck Replacement Project. Phase 2 Update:

Will be informed if we awarded the grant the second week in November, and if so, then the inspection will be done in mid-November.

15. Fire Truck Replacement Project. Phase 3 Update:

The meeting with CIB for the grant money went well; we were dinged on a few things that need to be addressed next time. On October 6, 2022, we will determine if the grant money will be awarded.

We will need to establish a bond company and have a public hearing.
