- Geological Signs have been installed in Big Cottonwood: Remnants of an Ancient Sea (MP 2.3); Mississippian Marble (MP 7.2); Storm Mountain Quartzites (MP 2.8). Funding was provided by the CWC, Town of Brighton, and the Utah Geological Association.
