

**Minutes of the North Logan City  
Redevelopment Agency Meeting  
Held on June 1, 2022  
At the North Logan City Library, North Logan, Utah**

*Craig Humphreys made a motion to adjourn the City Council meeting and convene to the meeting of the North Logan Redevelopment Agency. Emily Schmidt seconded the motion. A vote was called and the motion passed unanimously with Roger Anderson, Buzzy Mullahkhel, Craig Humphreys, Joni Kartchner and Emily Schmidt voting in favor.*

**Adoption of Agenda**

*Emily Schmidt made a motion to adopt the agenda as presented. Craig Humphreys seconded the motion. A vote was called and the motion passed unanimously with Roger Anderson, Buzzy Mullahkhel, Craig Humphreys, Joni Kartchner and Emily Schmidt voting in favor.*

**New Business**

*Craig Humphreys made a motion to adjourn the RDA meeting and return to the regular portion of the City Council meeting. Joni Kartchner seconded the motion. A vote was called and the motion passed unanimously with Roger Anderson, Buzzy Mullahkhel, Craig Humphreys, Joni Kartchner and Emily Schmidt voting in favor.*
