

Summary of Appointments.

1. Douglas Scott Lofthouse-Proposed QA Replacement for Global Force USA.

2. James Christensen-Proposed QA for Fiore Industries Inc.

3. Grayden Sterling Cluff, Application for Unarmed Private Security Officer License.
 - a. On or about July 27, 2022, Applicant submitted an application to the Division to operate as an Unarmed Private Security Officer. As part of the application, Applicant disclosed that they had criminal action pending. That action has since been adjudicated.
 - b. Applicant, on or about January 14, 2021, in Salt Lake City Justice Court, Utah, case number 201404661, pleaded guilty to Assault, a class B misdemeanor. This plea was held in abeyance. Due non-compliance, plea in abeyance was extended for an additional 364 days on February 04, 2022.
4. Tyler Scott Millaway, Application for Unarmed Private Security Officer License.
 - a. On or about June 22, 2022, Applicant submitted an application to the Division to operate as an Unarmed Private Security Officer. As part of the application, Applicant disclosed that they had previously been convicted of a misdemeanor.
 - b. Applicant, on or about March 18, 2019, in Roy/Weber Justice Court, Utah, case number 191300027, pleaded guilty to Possession of Controlled Substance Marijuana/Spice, a class B misdemeanor.
 - i. **Probable cause statement:** "On 01-14-19 at 1047, I was dispatched to [REDACTED] in Roy, on a report of a drug violation involving Tyler Millaway. Upon arrival, I spoke with Tyler's father Weber County Deputy(Sgt.) John Millaway, who stated his adult son was inside the house and is smoking marijuana in his room. Mr. Millaway stated he did go into Tyler's room and saw marijuana all spread over the top of Tyler's bed. Mr. Millaway invited me into his residence and had me go upstairs to Tyler's room. The door was locked and Tyler would not open the door. Mr. Millaway then opened the door to his son Tyler's room and I was immediately hit with the strong odor of burnt marijuana and visually could see a smoky haze coming from the room. Mr. Millaway stepped into the room and began speaking with Tyler, due to the strong odor of burnt marijuana and being able to see a smoky haze in the room, I then stepped into the room. I did observe scattered amounts of a green leafy substance on the top

of the blue bed sheet. I then advised Tyler he was under arrest for possession of marijuana and while placing hand cuffs on him, I then saw a clear plastic baggy containing a green leafy substance on the top of the desk, next to him. I also observe green leafy substance scattered all over the top of the desk as well and a soda can, which had been manipulated to be used a smoking pipe. I did observe freshly burnt residue on the soda can. Tyler was advised of his Miranda Rights, but refused to speak with me. I did obtain a written statement from Mr. Millaway.”

- c. Applicant, on or about July 22, 2019, in Roy/Weber Justice Court, Utah, case number 191300302, pleaded guilty to Attempted Assault, a class B misdemeanor.

- i. **Probable Cause Statement:** “On 5-12-19 Officer's responded to [REDACTED] on a family fight. Upon arrival, I made contact with the victim who stated her brother, Tyler Millaway assaulted her. She continued to say she got in a verbal argument with him when all of a sudden he shoved her in the throat with his hand. The victim then told Tyler not to touch her, and he shoved her in the throat again. It should be noted there were also several witnesses who saw this happen. One of the witnesses stated Tyler crossed the line by shoving the victim in the neck twice. Due to Tyler shoving the victim twice in the neck and it possibly causing bodily injury to another person, Tyler was booked for DV Assault.”

- d. Applicant, on or about March 02, 2020, in Roy/Weber Justice Court, Utah, case number 201300050, pleaded guilty to criminal mischief intentional damage, deface, destroy property, a class B misdemeanor.

- i. **Probable Cause Statement:** “On 01/23/20 around 1619 hours, I responded to [REDACTED] in Roy on a weapons disturbance complaint. Tyler Millaway (21) got upset because his mother would not give him a ride to jujitsu class, and she would not give him any money to purchase marijuana. Tyler grabbed a hammer and struck a Vizio television, which was hanging in the kitchen, numerous times, causing damage to the screen. Tyler then threatened his mother, saying that he was going to make her life miserable. Tyler's mother and his adult sister were scared, and they were afraid that Tyler was going to try and hurt them, so they ran and hid, and called the police.”

5. Gregory Christian Hale, Application for Armed Private Security Officer License.

- a. On or about August 01, 2022, Applicant submitted an application to the Division to operate as an Armed Private Security Officer. As part of the application, Applicant disclosed that they had previously been convicted of a misdemeanor.

- b. Applicant, on or about June 21, 2017, in Orem City Justice Court, Utah, case number

171900584, pleaded no contest to discharge of a firearm in city limits, a class B misdemeanor.

- i. **Probable Cause Statement from UVU Police Department:** “I responded to a call stating a firearm accidentally discharged in the Liberal Arts hallway next to the Taco Bell and Green Line Cafe. Upon arrival I found the owner of the firearm, Gregory Hale, and spoke with him about the incident. In his statement he says he was sitting at a table next to the Green Line Cafe facing north. His firearm (Smith & Wesson Shield 4~.) was inside his bag which was on top of the table. Gregory was sitting at the table for about two hours. While he was putting his books into his bag, the pistol accidentally fired 1 round while still being in the nylon holster. There were no injuries. The bullet exited the bag heading north down the LA hallway. It ricocheted off the table sending the bullet upwards down the LA hallway. The bullet passed through a light fixture and made contact with a pipe in the ceiling. The already fired bullet was found on the floor in the middle of the LA hallway. Gregory's pistol along with his magazines and the rest of his ammunition was seized for safekeeping until further notice. Gregory does have a valid concealed carry permit. His statement and pictures of the incident are included in the report.”
