Mountain West Development would like to request a 1 year extension to our final plat approval from January of this year as we work through the final steps needed to cooperatively design the water system updates with LDWA and the septic/sewer design. We still want to move forward as soon as possible on the project but would appreciate the extension. A few updates on the project:

- 1) Water: We have successfully found water that has been accepted by LDWA, but now we need some extra time to work with LDWA on the construction drawings and details around system updates and changes in order to record.
