DANENE JACKSON, FINANCE MANAGER – IN THE PACKET THERE ARE 3 SCHEDULES:

- THE FIRST IS A BUDGET TO ACTUAL TRACKING SCHEDULE. EVERYTHING IS ON TRACK WITH BUDGET. THERE ARE NO UNEXPECTED VARIATIONS FROM THE BUDGET.
- THE NEXT IS THE BALANCE SHEET WHICH ARE THE CASH BALANCES, ACCOUNTS RECEIVABLE AND THE FUND BALANCE. THE CONDITION OF THOSE ITEMS HAS NOT CHANGED MATERIALLY. THE DISTRICT HAS A POSITIVE CASH BALANCE FOR BOTH THE GENERAL FUND AND THE CAPITAL PROJECT FUND.
- THE LAST SCHEDULE IS THE INCOME STATEMENT WHICH SHOWS THE BREAKDOWN OF THE REVENUES AND EXPENDITURES. THERE IS NOTHING THAT IS VARYING. THE DISTRICT IS IN A FAVORABLE FINANCIAL POSITION.

COMMISSIONER SAKIEVICH – THE \$2 MILLION IS THE ARPA (AMERICAN RESCUE PLAN ACT OF 2021) FUNDING FOR THE NEW WELL?

BRADY CHRISTENSEN, PUBLIC WORKS DIVISION MANAGER – THE ARPA FUNDING IS IN PLACE AND WE ARE IN THE PROCESS OF GETTING THE SPECIFICATIONS SO WE CAN SEND THAT OUT TO BID AND GET THE WATER LINES IN PLACE.

DANENE JACKSON, FINANCE MANAGER – THERE IS A LIEN THAT HAS BEEN ISSUED. THE BOARD APPROVED THAT DURING THE MEETING IN MAY AND THEN 3 LOTS HAVE BEEN SENT SECOND NOTICES SO THEY'LL BE RECEIVING A NOTICE OF DISCONNECTION WITHIN THE MONTH THAT COULD ALSO LEAD TO POTENTIAL LIENS. THAT WOULD BE AN ACTION THAT I WOULD RECOMMEND FOR THE BOARD TODAY TO GO AHEAD AND APPROVE THAT IF THERE IS NO RESPONSE TO THE NOTICE OF DISCONNECTION. THEN THERE'S 33 PROPERTY OWNERS THAT HAVE UNPAID BALANCES THAT ARE OLDER THAN 30 DAYS. MOST OF THE TIME THOSE GET CAUGHT UP.

DANENE JACKSON, FINANCE MANAGER – THIS IS SOMETHING THAT IS ON THE AGENDA ONCE A YEAR. THERE HAVEN'T BEEN ANY MATERIAL CHANGES IN THE CAPITAL PROJECT PLAN AND THE ARPA PROJECT IS ON THE PLAN IN 2022. TIMING-WISE, THE FUNDS HAD TO BE ENCUMBERED BY 2024 WHICH THAT IS DONE AND THEN THE DISTRICT WILL HAVE UNTIL THE END OF 2026 TO ACTUALLY SPEND THE FUNDS SO THAT PROJECT MAY ACTUALLY GO MULTIPLE YEARS.

SPENCER PARK - WHAT IS 'SOFT STARTS ON PUMPS' THAT IS LISTED?

BRADY CHRISTENSEN, PUBLIC WORKS DIVISION MANAGER – THEY ARE INSTALLED LESSEN THE POWER LOAD. THEY BRING THE PUMPS UP SLOWLY RATHER THAN WHEN YOU TURN THE BREAKER ON TO HAVE IT SURGE. THIS WILL BRING THE PUMPS UP SLOWLY SO THE POWER CONSUMPTION IS NOT QUITE AS BIG.

I KNOW THERE'S BEEN SOME OVERUSE OF WATER AND SOME OF THE LOTS BUT THAT SHOULD AFFECT PRESSURES. WE DID HAVE A COUPLE OF LEAKS THAT WE FOUND BUT THAT WAS LATER THIS SUMMER.

LAURIE SUDWEEKS – ROBERT BARRETT BROUGHT UP A QUESTION ABOUT THERE WERE SOME SHARES THAT HE HAD PURCHASED AND THAT WE WERE GOING TO HAVE SOMEONE LOOK INTO IT TO SEE IF THOSE SHARES WERE FOR SOLDIER SUMMIT.

BRADY CHRISTENSEN – THE WATER RIGHTS SPECIALISTS THAT WE HAVE ON CONTRACT NOW ARE LOOKING INTO THAT. WE GAVE THEM THAT INFORMATION OVER A MONTH AGO. THEY HAVE BEEN ASKING ALL TYPES AND QUESTIONS AND ARE WORKING ON IT, BUT AS OF YET, WE HAVE NOT HEARD A VERDICT ON WHETHER THAT WATER CAN TRANSFER.
