


Vision Statement

The BCC MAP will develop a strategy to guide local transportation investments over time by leveraging technology, foundational documents, and enhanced transit options to expand sustainable transportation choices and develop a robust mobility system that supports positive environmental, social, and economic outcomes for the region.

The BCC MAP will identify key projects, policies, <u>funding opportunities</u>, and process improvements to catalyze the vision for a regional, multi-modal, year-round mobility system serving all users of Big Cottonwood Canyon and facilitate the integration of new and emerging technologies, transportation demand management strategies, and enhanced transit options for Big Cottonwood Canyon.

Key Takeaways

The outcome of the BCC MAP is not a single solution that will solve a single problem. Rather, we are developing a "next steps" plan for a menu of options that will move the needle in the right direction for addressing:

- Lack of year-round transit service
- Insufficient winter transit service
- Insufficient connection to regional public transit system
- Parking
- Congestion, travel times
- Safety concerns



Focus on Mobility Solutions

- Increasing bus use and incentivizing transit
- Dis-incentivizing vehicle use (especially singleoccupant)
- Improved connection to regional public transit system
- Reducing congestion, peak-hour travel time
- Improving year-round access
- Addressing parking needs and reduction of onroad parking



Outcome of BCC MAP

- Focus on multimodal mobility
- Prioritize investments and solutions that collectively address the spectrum of mobility issues and needs in BCC
- Funding, timeline, and process for implementation
- Support, progress CWC strategic goals



Next Steps

- Public survey
- Confirm menu of solutions to address aforementioned issues
 - Progress concepts for potential mobility hubs
 - Incorporate previously identified solutions
 - Further develop new, outside-the-box solutions
- Develop implementation plan, including funding options, timeline, environmental next steps, jurisdictional responsibility, public outreach/equity considerations, etc.
