The State of Utah School and Institutional Trust Lands System provides significant funding to support public schools at no cost to taxpayers. A record \$96 million was distributed to Utah schools for the 2022- 2023 school year. Money is earned from 4.4 million surface and mineral acres managed by the Trust. These lands are not public lands; they are lands designated at statehood by Congress specifically to generate revenue to support designated beneficiaries, including public schools. Revenues generated from energy, real estate, and surface resources, along with investment earnings have grown the permanent fund to exceed \$3.2 billion today.

# What are School Community Councils?

School Community Councils (SCC) are a unique and powerful way for parents to have a direct impact on student achievement.

Every school must have a SCC that consists of parents, school employees and the principal. Councils are parent-majority and provide a vital perspective to the needs of the school. SCCs meet regularly to discuss various topics of interest and develop Teacher and Student Success Plans.



### The Role of a School Community Council



SCCs develop a School LAND Trust Plan that uses School LAND trust funding to address a school's greatest academic need.



Parents may bring issues of concern to the council seeking solutions. The Council may choose to address them or recommend another group or entity better suited to implement solutions.



They may make recommendations to the administration of the school and district
