2. CITIZEN PUBLIC INPUT

Mr. Lawrence Hormann stated a member of the Salt Lake Valley Coalition to End Homelessness recently lost her life due, in part, to the improper handling of an encounter with law enforcement. He would like law enforcement officers to receive training on how to deescalate incidents with the homeless.

Council Member Stringham stated the Municipal Services District, with the help of several members of the Utah House of Representatives, received about \$10 million in Federal funding for a project in Kearns.

Council Member Stewart asked when the United Fire Authority board appointments would take place.

Council Member Newton stated an email was sent earlier asking for feedback. The feedback would be compiled and distributed this week. If time permitted, it would be put on the agenda for the next meeting.

Council Member Stewart asked if all Council meetings following a Monday holiday were to be cancelled. He was unsure if he needed to take time off for a business trip.

WHEREAS, mentoring programs like Big Brothers Big Sisters of Utah make our county and communities stronger by enabling impactful relationships that increase social capital for young people and provide invaluable support networks; and

WHEREAS, throughout the COVID-19 pandemic, mentoring programs have stepped up to ensure that mentoring relationships continued virtually, while also connecting families to critical resources and services; and

WHEREAS, mentors can help young people explore careers and build skills to achieve higher lifetime economic outcomes through activities like helping them set career goals, write a resume, practice for an interview, connecting them to opportunities, and more; and

WHEREAS, research has demonstrated that mentoring programs have a significant, positive impact on a variety of academic achievement measures, including truancy and absenteeism, scholastic efficacy and engagement, school-related misconduct, and peer support; and

WHEREAS, mentoring can be an especially effective prevention and intervention strategy for young people with marginalized identities, such as youth with disabilities, BIPOC youth, LGBTQIA+ youth, and youth with experience in foster care; and

WHEREAS, quality mentoring promotes healthy relationships and communication, positive self-esteem, emotional well-being, and relationship growth for young people; and

WHEREAS, with a mentor, youth facing risk are more likely to enroll in college, less likely to start using drugs, and more likely to volunteer regularly in their communities; and

WHEREAS, while one in three young people still grow up without a mentor, demonstrating the need for additional awareness and resources for mentoring programs; and

WHEREAS, Utah Mentoring Month is the time of year to celebrate, elevate, and encourage mentoring throughout our county and recruit caring adult mentors in Salt Lake County;

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL APPROVING AN INTERLOCAL COOPERATION AGREEMENT WITH THE JORDAN VALLEY WATER CONSERVANCY DISTRICT PROVIDING FOR THE TRANSFER OF AMERICAN RESCUE PLAN ACT (ARPA) FISCAL RECOVERY FUNDS FOR AN INTEGRATED LAND USE AND WATER CONSERVATION MUNICIPAL PARTNERSHIP.

WITNESSETH

WHEREAS, Salt Lake County (the “County”) and the Jordan Valley Water Conservancy District (the “District”) are “public agencies” as defined by the Utah Interlocal Cooperation Act, UTAH CODE §§ 11-13-101 to -608, and are therefore authorized to enter into an Agreement to act jointly and cooperatively in a manner that will enable them to make the most efficient use of their resources and powers; and

WHEREAS, the County has received federal funds under section 603(b) of the Social Security Act as added by section 9901 of the American Rescue Plan Act (Public Law 117-2) (March 11, 2021) (“ARPA Funds”) to provide funding to combat and address the effects of the novel Coronavirus Disease 2019 within Salt Lake County; and

WHEREAS, the County desires to use a portion of the ARPA Funds, in partnership with the District and the Utah League of Cities and Towns, to help integrate municipal land use planning with water resource conservation and planning; and

WHEREAS, the County now desires to enter into an interlocal cooperation agreement with the District, which agreement is attached hereto as **ATTACHMENT A** (the “Interlocal Agreement”), to provide for the transfer


