## 2. CITIZEN PUBLIC INPUT

**Mr. Rhett Wimmer**, Board Member, Utah Chapter of the Foundation Against Intolerance and Racism (FAIR), stated he is concerned that the Sandy Library is aggressively promoting certain ideological views over others in the display space of its children's section. Of the eighty-five books in the display, 16 percent focus on race, 11 percent focus on the climate crisis, 9 percent focus on critical social justice, and 5 percent are biographies of Democratic politicians. There were no biographies of conservative or Libertarian politicians, white or Latin Americans, founding fathers, or mathematicians. FAIR opposes any banning or limiting of books from public libraries and promotes neutrality.

SECTION I. The amendments made herein are designated by underlining the new substituted words. Words being deleted are designated by brackets and strike-through.

### **2.04.080 - Regular Meetings.**

- A. To fund the acquisition, construction, renovation, and equipping of parks and recreation facilities and related improvements, Salt Lake County ("County") sought approval by voters in the November 8, 2016 general election to issue general obligation bonds in an amount not to exceed Ninety Million Dollars (\$90,000,000) (the "Recreation Bonds").
- B. Salt Lake City ("City") submitted a Recreation Bonds Application proposing to replace an accessory building at its recreation facility known as Oak Hills Tennis Center with a new clubhouse ("Facility") for which it will receive a contribution of County Recreation Bonds funds in the amount of \$1,750,000.00
- C. County and City entered into an Interlocal Cooperation Agreement, Salt Lake County Contract No. 0000001949 ("the Agreement") whereby the County contributed the Recreation Bonds funds for City to complete the desired improvements to its Facility.
- D. The adoption of the Agreement was made pursuant to the Utah Interlocal Cooperation Act, U.C.A. § 11-13-101 et seq. (the "Act").
- E. The Agreement requires the City to construct an improvement to real property thereby requiring approval of the County's legislative body pursuant to the Act.
- F. The Agreement expired on December 31, 2002, but the work is not to be complete.
- G. The City and the County wish to amend the Agreement to extend the termination date.
- H. The amendment of the Agreement is in the best interests of the parties and in furtherance of the public interest.

WHEREAS, Salt Lake County (the “County”) and West Valley City (the “City”) are “public agencies” as defined by the Utah Interlocal Cooperation Act, Utah Code § 11-13-101 to -608, and are therefore authorized to enter into an Agreement to act jointly and cooperatively in a manner that will enable them to make the most efficient use of their resources and powers; and

WHEREAS, during the 2018 General Session, the Utah State Legislature enacted Senate Bill 136, which allowed for a one percent local option sales and use tax, which is used by the County in its Regional Transportation Choice Fund (4th Quarter), which provides for on-going transportation funding in Salt Lake County (hereinafter “Transportation Funds”); and

WHEREAS, the County has appropriated Transportation Funds to further regional transportation by financing all or a portion of the costs of transportation projects throughout the County in accordance with Utah Code § 59-12-2219 and all other applicable federal, state, and local laws, rules and regulations; and

WHEREAS, among these transportation projects is the Cross Towne Trail project; and

WHEREAS, because the Project is located in West Valley City, the County has sought the participation of the City to complete the Project. The Parties now desire to enter into this Agreement providing for the transfer of up to One Million Three Hundred Fifty Thousand Dollars (\$1,350,000) of Transportation Funds to the City to reimburse the City for certain costs incurred by the City to complete the Project; and
