2 **R277-329. Local School District Board Policies for Evaluation of Classified**  
3 **Employees.**

4 **R277-329-1. Authority and Purpose.**

5 \_\_\_\_\_ (1) This rule is authorized by:

6 \_\_\_\_\_ (a) Utah Constitution [Article X, Section 3](#), which vests general control and  
7 supervision of public education in the Board;

8 \_\_\_\_\_ (b) Subsection [53E-3-401\(4\)](#), which allows the Board to make rules to execute the  
9 Board's duties and responsibilities under the Utah Constitution and state law; and

10 \_\_\_\_\_ (c) Section [53G-11-504](#), which directs the Board to develop rules requiring that  
11 school districts evaluate all employees.

12 \_\_\_\_\_ (2) The purpose of this rule is to direct public school districts to adopt policies for the  
13 evaluation~~;~~ and dismissal ~~[and compensation]~~ of classified employees.

15 **R277-329-2. Definitions.**

16 "Classified employee" means a school district employee who is working in a position  
17 that does not require a Utah educator license.

19 **R277-329-3. School District Policies.**

20 \_\_\_\_\_ (1) A school district shall adopt policies for classified employees, including:

21 \_\_\_\_\_ (a) policies for evaluation and dismissal consistent with minimum standards of:

22 \_\_\_\_\_ (i) Sections [53G-11-504](#) through [53G-11-505](#); and

23 \_\_\_\_\_ (ii) Sections [53G-11-512](#) through [53G-11-517](#); and

24 \_\_\_\_\_ (b) evaluation procedures with the following components:

25 \_\_\_\_\_ (i) the annual evaluation of classified employees;

26 \_\_\_\_\_ (ii) the use of appropriate tools for classified employee evaluations;

27 \_\_\_\_\_ (iii) classified employee evaluation criteria tied to specific job descriptions or  
28 assignments;

29 \_\_\_\_\_ (iv) the administration of the evaluation by the school principal, an appropriate  
30 administrator, or the principal's or administrator's designee; and

31 \_\_\_\_\_ (v) an appeals process that allows classified employees to appeal procedural

32 violations of the evaluation process.

33 (2) School district evaluation policies for classified employees may include additional  
34 components beyond those specified in Subsection (1).

35 (3) A school district's policies may exclude temporary or part-time classified  
36 employees from performance evaluations, as provided in Subsection [53G-11-504\(2\)](#).
