11. Public Works Update - Lane Genereaux

Minutes:

Lane Genereaux gave the public works update. * He said they had just bought a trench box. He is very impressed with the way it was made and how easy it will be to use. * The City also purchased a plate compactor so they can now do its own road patches.. *The 1- ton truck is broken down. L&L will pick it up and tow it to Roosevelt. They will get a quote to fix it as soon as they can. *The loader needs a new motor, the cost to fix it will be about \$32,000 without labor. Jim Rhoades has been working on it, but has not yet sent a bill. * The City has leased 5 new trucks. The trucks previously leased have been returned. * The mowers will probably make it through the summer * Big blue (truck) is working but it's not worth fixing anymore. They were going to transfer everything over to the yellow truck, but the plow won't fit. * There are 2 water services that need to be put in. Aaron Rowley is putting in his own. * They will be starting a valve exercising project. This will include fire hydrants. * The pump is up and running on the bench. * Twin D will be coming back to do \$10,000 worth of work on the sewer. * There is a big mess at the dump station. * Cole is getting ready to take care of the parks. * There are some bases that need to be ordered for the cemetery. * Work will begin at the pool in about 2 weeks. * There are about 600 sand bags. Mayor Rowley said we need about 30,000- 40,000. He will get some ordered.
