- **School LAND Trust**
 - SLT Training Assurances – Bryan DeGrange made assurances that all board members. Mary, Rene, Bryan and Jerrad have done the training. Nate still needs to watch the video.

VOTING ITEMS

- UDOT Board Resolution – Platte Nielson stated that he and Dale has been working with UDOT on a partial piece of land for a light pole (36 sq feet). There have been a few issues. However, the contract is ready, he has gotten approval from the bond counsel, the loan agreement amended, and the partial reconveyance drafted. All the paperwork is in order. They have received an appraisal. UDOT will pay \$500 and closing costs. By approving this resolution, which references the Loan Agreement, Deed of Partial Reconveyance, and the UDOT Real Estate Purchase Agreement, you can sign the purchase agreement today but not the loan agreement or deed for reconveyance until after it closes sometime in April.
- 2023-2024 Antelope School LAND Trust Plan – Becky Okey reviewed the first two goals of the Antelope SLT Plan, the measurement, action plan and the spending. Art Hansen reviewed the third and fourth goal of the Antelope SLT Plan, the measurement, action plan and the spending for the Jr. high. There was a discussion on clarification on the goals vs. measurements. There was a discussion on the carry over not being correct on the information in the packet. The SLT website isn't correct and hopefully it will be fixed before they finalize their FY24 plans. Dale stated that he sent an email to the board with the FY22 expenditures and informed the board that those final numbers haven't been uploaded to the website. There was a discussion on the incorrect numbers on the SLT website.
- 2023-2024 North School LAND Trust Plan – Dale Pfister stated that the numbers on Judy's plan are correct for FY24 distribution but because of the incorrect website numbers it's not showing a correct balance. Because of the incorrect numbers, there was a discussion on the approving the plan based on the goals and the summary of estimated expenditures.
- Washington DC Student Trip – Dale Pfister reviewed the Jr. High Washington DC trip expenditures per person. Everyone has pre-paid for the trip. There may be small additional costs for transportation that could possibly be reimbursed after the fact. **Jerrad Pullum made a motion to approve the following:**
 - **Approve the UDOT Board Resolution which includes the UDOT Real Estate Purchase Contract, the Third Amendment to Loan Agreement and the Deed of Partial Reconveyance;**
 - **Approve the 2023-2024 School LAND Trust Plan including the goals, measurements, action plan and spending for the Antelope Campus;**
 - **Approve the 2023-2024 School LAND Trust Plan including the goals, measurements, action plan and spending for the North Campus; and**
 - **Approve the Junior High Honor Guard student trip expense to Washington DC not to exceed \$35,000.**

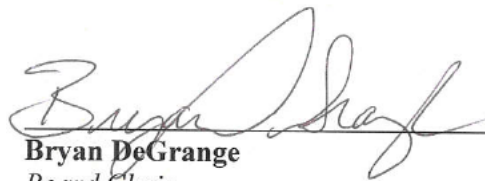


CLOSED SESSION SWORN STATEMENT:
