**4. Discussion of SLVLESA services**

Trustee Bush explained a number of concerns regarding a Bill that is expected to be considered by the Legislature this year. Mark Anderson provided insights about the Bill and options, all of which would place the MSD member agencies in a predicament regarding law enforcement services, in the event the Bill becomes law. A general discussion of SLVLESA (Salt Lake Valley Law Enforcement Service Area) and UPD (Unified Police Department) followed.

Trustee Stringham joined the meeting at 2:21 p.m.

Trustee Stringham stated several points and issues that can and should be discussed with people to educate them on what is happening regarding the UPD Bill. It was suggested that Mark Anderson collect “talking points” to present a united front on the Bill.

**5. Discussion regarding deployment of security personnel, devices, or systems (possible closed meeting pursuant to Utah Code Ann. § 52-4-205(1)(f))**

There was no need to close the meeting.

**6. Approve position on legislative action**

**Trustee Flint moved to oppose the UPD Bill in its current form. Trustee Peay seconded the motion. The motion carried with Trustees Smolka, Bush, Clayton, Flint, Peay, Stringham and Zuspan each voting “aye”.**

Trustee Bush stated that Nathan Bracken will be working with the Legislature in opposition to the Bill.

Trustee Clayton left the meeting at 2:40 p.m.

Chair Smolka reiterated that Mark Anderson will collect Bill talking points and would like to have well thought-out comments by Monday.

Marla Howard asked if the Bill would do away with SLVLESA or if SLVLESA would continue to be a viable entity. Mark Anderson responded that, in its current form, the Bill would not do away with SLVLESA, but it would do away with UPD.

Chair Smolka declared the meeting to be adjourned without objection at 3:04 p.m.
