### CITY OF WEST JORDAN NOTICE OF PUBLIC HEARING

A public hearing will be held before the West Jordan City Council on **Wednesday, May 24, 2023 at 6:00 pm**, or as soon thereafter as possible in the **Thomas M. Rees Justice Center, Community Room, 1<sup>st</sup> Floor, 8040 S Redwood Rd, West Jordan, UT 84088**. The purpose of the hearing is to receive public comments regarding a substantial amendment to the West Jordan Community Development Block Grant Program Year 2022 Annual Action Plan for the transfer of \$24,929 from Contingency to the project Emergency Home Repair and Access Improvements.

Proposed balance of the funds is as follows:

#### **FROM - Contingency**

Current Funding \$53,393

Proposed Funding \$28,464

#### **TO - Emergency Home Repair and Access Improvements**

Current Funding \$150,071

Proposed Funding \$175,000

No projects or activities will be deleted.
