SUMMARY

On September 13th, 2021, the United States Department of Housing and Urban Development (HUD) released a notice outlining a specialized version of the existing HOME housing development program.

This new one-time federal allocation, named HOME-ARP, provides \$12.9mm to the State of Utah to perform four activities that are required to primarily benefit qualifying individuals and families who are homeless, at risk of homelessness, or in other vulnerable populations.

The allowable project types are affordable housing development, non-congregate shelter development, supportive services programs, and tenant based rental assistance. After conducting outreach across the state and submitting to HUD an allocation plan outlining the needs of the state, it was determined that all project types except tenant based rental assistance would be prioritized for this funding.

The Office of Homeless Services released a Request for Grant Applications (RFGA) to allocate this funding in Fall of 2023. Two (2) applications were received for Non-congregate shelter development, nine (9) for affordable housing development, and 11 for supportive services programs, resulting in 22 applications.

After applications were reviewed by a variety of community housing and homeless services experts, 13 projects were awarded funding totaling \$9.7mm. Appendix B: HOME-ARP Funded Project List provides additional information regarding the awarded applications.

Additionally, HUD allowed for a portion of the state award to go towards non-profit operating and capacity building. Projects that applied for and qualified for that specialized portion of the funding were awarded additional project funding proportionally. This secondary award totaled \$1.29mm across 8 agencies.
