Notes for January 11th meeting and Agenda approved.

### Presentation: 2023 Utah Legislative Session Report (00:06:40)

Casey Snider, Utah House of Representatives, provided an update on the 2023 legislation pertaining to GSL including Water Reuse Amendments (HB 349), Amendments related to GSL (HB 491), GSL Amendments (HB 513). The major outcomes of this legislation include a prohibition on water reuse in the GSL watershed, the establishment of a GSL Commissioner, Lithium severance tax provisions, emergency lake management by FFSL, and funding investments, as well as related legislation that did not pass.

### Presentation: Water Supply Update for 2023 (00:35:20)

Glen Merrill, National Weather Service, presented on the snow levels for the major basins of the GSL, reservoir capacities, and near term forecast for the area.

### State Board and Commission Training (01:07:00)

Emma Whitaker, Assistant Attorney General provided required board training to the committee.

### Public comments (01:16:50)

Lynn De Freitas provided an update on the Stegner Symposium on Great Salt Lake, requested a future agenda item from Farm Bureau and their legislative perspective, and a meeting with the newly appointed Commissioner in May. R. Jefre Hicks discussed concerns related to water districts having to bid on water rights and the competing interest of the state and GSL. Marisa Weinberg made an announcement regarding volunteering for the April 24<sup>th</sup> shorebird survey organized by the Sageland Collaborative and the upcoming

Tech Team Grant announcement. In addition, she reported on the raising of the causeway control berm to 4,192 feet and the development of the associated berm management plan.

**Other Member Discussion, Recommendations & Actions (01:21:10)**

Don encouraged the group to provide ideas for funding projects through the GSLAC. Joe Havasi recommended a presentation from BYU on the economic analysis for GSL at the next meeting and a future discussion on water reuse project that are currently in the works. Tom Ward suggested hearing about the Agricultural Efficiency projects and ways that program can benefit the lake. Steve Erickson suggested having Water Rights discuss funding they received for groundwater studies and measurements. Candice Hasenyager suggested a presentation on the GSL Basin Integrated Plan in July or September.
