# **BUSINESS MEETING**

1) Dark Sky Ordinance language review and updating graphical content. Revisions incorporated from this work session will be delivered to the Metro Township Council for a recommendation to proceed with the Public Hearing. **Planner:** Matt Starley

Mr. Starley provided a PowerPoint presentation.

Commissioners and Staff had a brief discussion regarding grammar and language.

19.73.110 – Renumber to reflect Purpose 1, 5, 4, 7, 3, 6, and 2. Delete numbers 4 and 7. Made changes to each number and language as follows:

- 1. Encourage lighting practices that minimize light pollution, glare, light trespass, and sky glow to preserve the night and enhance sky.
- 2. Maintain the rural atmosphere and community character of the Metro Township.
- 3. Maintain nighttime safety, utility, and security.
- 4. Protect ecological conditions and nocturnal wildlife within the Metro Township.

- 5. Encourage lighting practices that promote energy conservation.
- 19.73.111 A. Change Compliance to "Compliant"
  - B. Nonconforming to "Non-Compliant".
    - 1. Change a nonconforming use to "non-Compliant lighting".
  - C. 1. ii. Change 19.73.110 to 19.73.117
- 19.73.115 E. 2. Add "light falls only on the deck or patio".
- 19.73.117 B. Define Director or Designee.
- 19.73.119 Move definitions to the front of the Ordinance and delete A-M and N-Z.

Basement – Repeal and replace with "An area of the building having its floor (below ground level on all sides".

B.U.G Rating – Remove periods from BUG.

*Direct Illumination – Remove the word "luminary" after lamp.* 

Fixture – Repeal and replace with Luminaire "A complete lighting unit that typically includes components such as a fixture housing, ballasts, reflector, shield or diffuser, and a lamp or lamps. Move Luminaire graphic under fixture.

Footcandle – Add "one-foot square located one foot from the light source with one lumen of light".

Fully Shielded Fixture – Repeal and replace with "An outdoor light fixture constructed and mounted so that the installed fixture emits no light above the horizontal plane.

*Illuminance – Repeal and replace with "Light level measured in foot candles, lux, or lumens.* 

Lighting Controls – Rewrite "Photocell Sensors automatically turn lights on and off in response to natural light levels. Some advanced modes can slowly dim or increase the lighting level".

Repeal "Low Pressure Sodium" as a whole.

Lumen – Rewrite "A Lumen a measurement of light".

*Graphic – Comparison of Bulbs – Delete and cost and remove the dollar amount.* 

*Lux Graphic – Correct the word indicated to "Indicates".* 

*Outdoor Light Fixture – Delete the full last sentence.* 

*Partially Shielded Light Fixture – Delete everything after the first sentence.* 

Pool Lighting - Repeal and replace with "Light fixtures located below the service of the water.

Recreational Lighting – Delete the word "ball" and add "ice rinks".

Religious Institutions – Repeal and relace with "Property containing a Church, Synagogue, Mosque, Temple, Cathedral, or other religious or spiritually-oriented structure(s), accessory or structures, where persons regularly assemble for religious or spiritual purposes and related social events".

*Unshielded Lighting Fixture – Delete graphic.*
