BUSINESS MEETING

1) Updates to Municipal Code: 19.73.110 Night Lighting proposed draft language in anticipation of the development of a complete draft preparation for public hearing. **Planner:** Matt Starley.

Commissioners and staff had a brief discussion regarding definitions.

Remove - "or Designee" from Director.

BUG Rating – recommend adding "behind the <u>light fixture</u>".

Remove - "The appropriate glare rating is determined by the community" from the BUG Ratings graphic figure 01.

Add "Nadir" definition – The direction pointing directly below a particular location.

Change Fixture Lumens – replace "processing of emitted light by" to "passing through the".

Remove – "Discouraged" from Figure 06 from Unacceptable/Discouraged.

Remove – "(fixture)" from Incandescent lamp and add "high temperature by <u>an</u> electric current".

kWh – repeal the whole definition and replace with "A measure of electrical energy measurable to 1000 watts for one hour.

Remove – "chips on board" to "diode in Light Source.

Add - "Light" to Trespassing within figure 09 graphic.

Mounting Height – Add "<u>light fixture</u>" and "the height of the <u>mounting element from ground plane</u> to lowest elevation".

Multi-Family Residential Property – repeal "three to ten dwelling units" replace with "or more".

Religious Institutions – Remove "Church, Synagogue, Mosque, Temple, Cathedral, or other".

Commissioners and Staff had a brief discussion regarding 19.73.118.

Lighting Plan Required - Number 1 delete the word "requires", add "the applicant shall", and add "determine whether the proposed lighting".
