A. CALL TO ORDER:

Ray made a recommendation to make sure there is money going toward water for emergency preparedness.

F. BUSINESS:

The council discussed business item F5.

1. **Discussion and possible action** on Ordinance 2023.XX – Modifying Toquerville City Code Chapter 7 – Cemetery.

City Manager Moore reviewed the Cemetery Ordinance changes and the requested policy. Staff and Attorney Snow answered questions from the councilmembers.

Councilman Bringhurst was excused from the meeting at 6:50 pm.

Councilman Campbell motioned table business item F2(1). Councilman Sands seconded the motion. Motion carried, 4-0. Joey Campbell – aye, Gary Chaves – aye, Chuck Williams – aye, Todd Sands – aye.

City Manager Moore reviewed the proposed changes with council. She answered questions from Attorney Snow and Council.

Discussion and possible action on Ordinance 2023.XX – Modifying Toquerville City Code
Title 10, Chapter 17, Article 3 – Nightly Rental Ordinance.
Ryker Steglich and Shaun Huntsman reviewed recommended changes to the ordinance.
Council, Attorney Snow and staff discussed this ordinance.

Councilman Campbell motioned to approve the nightly rental ordinance with changes to add definition that was struck back in on letter C, add verbiage provided by Attorney Snow to create H(A) and change 'shall' to 'may' in L(F). Councilman Sands seconded the motion. Councilman Campbell amended his motion to add A(F) a fire inspection is required during application process. Councilman Sands seconded the amended motion. Motion carried, 4-0. Joey Campbell – aye, Gary Chaves – aye, Chuck Williams – aye, Todd Sands – aye.

4. **Discussion and possible action** on Ordinance 2023.XX – Consolidation of Contiguous Lots and Parcels.

Ryker Steglich explained this ordinance and its suggested changes. Attorney Snow shared his comments to council. Council discussed the process.

Councilman Campbell motioned to approve as is. Councilman Chaves seconded the motion. Motion carried, 4-0. Joey Campbell – aye, Gary Chaves – aye, Chuck Williams – aye, Todd Sands – aye.

 - T-149-A-5 12.99 acres current zoning is Single Family residential R-1-20
 - T-149 -A-3 5.44 acres current zoning is Single Family Residential R-1-20
 - T-149-A-2-A 10.88 acres current zoning is Single Family Residential R-1-20
 - T-150-A-2-B-1 5.00 acres current zoning is Single Family Residential R-1-20
 - T-168-J 9.77 acres current zoning is Single Family Residential R-1-20. The proposed zoning is MU-20.

The applicant Jake Peart discussed the purpose and process of their application. Councilman Sands stated his interpretation on an MU-20 zone. The council requested an official interpretation on an MU-20 zone. Attorney Snow and council discussed zoning, conditional uses and MPDO zones. The applicant withdrew their application.
