Conservation/Sustainability Update

The committee consisting of Chloe Taurel, Montana Burack, Bridget Lane and Sonja Preston have been working on ways to conserve energy throughout the District and they presented their findings to the Board. Local commitments to current and future generations:

Summit County-reduce emissions 50% by 2030

Park City – net zero carbon +100% renewable energy by 2030

Park City Municipal – zero emissions by 2030

Park City Community Foundation – eliminate food waste by 2030

Purposed action steps by the committee include: district commitment to staffing, funding and transition funded by The Climate Fund.

Monthly Reports

PCEA-Mary Morgan and Jacob Jobe presented their report. A new co-president will step in for Jake at the end of the school year. PCEA has finished the compensation and professional agreement and they thanked the members of the team. PCEA thanked the Park City School Board and the Park City District Leadership for their strong support of teachers and all employees throughout this process. There were many hours spent working towards a common goal and we thank the Board along with the DO for an outcome that values the important work teachers do in Park City every day. PCEA also thanks all who have served on the Equity Policy committee. Many hours were spent involving a variety of voices from employees to community

members. This policy is essential for all of us as a community to address equity for all.

Gina Cox representing PCCA gave a brief update. She is thankful that employees were able to enter into negotiations early and that the board was willing to work with the groups”. Gina stated that employees felt heard and feel that they are valued members of PCSD.

Cindy Hair representing EIG thanked the Board for their willingness to negotiate and thanked them for their service to the students and the community. PCCEA and EIG worked very well together and she is hoping that this will continue.

Mike Tanner presented the operations update for the Board.

- PCSD will terminate COVID ops at the end of the school year. Some of the measures that were used, will still remain in place such as filters and touchless faucets in an order to keep our schools healthy.
- B&G crews are reviewing District facilities to determine what repairs need to be made due to the winter weather.
- The District has applied for \$400M for ebusses but we have a low probability of receiving any funds, we are however purchasing two propane buses this year.
- Currently training three PCHS staff as drivers to help support the driver shortage.
- Roof repairs will continue at PPES once school is out.
- EMS job study is wrapping up.

Zachary Smith-Student on the Board, said that as school is nearing the end, there are not a lot of planned activities. As a recap, Prom was very successful, with great student attendance at Snow Park. Parkchello car show was a success with over 30 cars showing up. Senior brunch will be held after graduation practice next week.

Superintendent Report

Dr. Gildea presented her monthly report focusing on excellent personnel. Our collective work is to ensure safety, achievement and opportunities. Park City School District is student-centered with a focus and emphasis on the whole child – our students are safe, supported, engaged, challenged and healthy. The District has 650 excellent personnel support for 4,350 K-12 students and 165 PreK students.

Dr. Gildea introduced the Inspiring and Supporting Committee who provided an overview of their work. Tracy Scheriff, Rebecca Gonzales, and Jacob Jobe presented the Draft Equity Policy. They shared the data and feedback that they have received regarding this policy. This process began in 2017 with our mission to inspire and support all students. 2018 an Equity Committee was formed. In June 2021 Utah Code R277-328 was adopted regarding equity.

After reviewing feedback, they found the following themes.

Member Caplan thanked everyone who has been on the committee and also thanked everyone for their patience. He is looking forward to continuing the conversation around this policy. He said that the Board hears the fears and concerns and they will work their way through this in an open dialogue.

Business Administrator, Randy Upton, provided a budget overview. Timeline for the budget process:

- June 1 – FY24 Tentative Budgets posted to Website
- June 8 – Summit County to release new Certified Tax Rate, Assessed Value, and Property Growth Values.
- June 20 – Adoption of Final FY23 and Proposed FY24 Budgets
 - Separate Hearing
 - Set Proposed tax rates and values.
- August 15 – If proposed tax increase, adopt FY 24 budget with applicable rates
 - Truth in Taxation Hearing
- Budget reports submitted to USBE and State Auditors office by end of August
- Budget book submitted to ASBO International for review no later than 90 days after adopted

Member Crossland made a motion to post Policy 1006 Education Equity. Member Peters seconded the motion. Motion passed unanimously.

Policy 10021 Dropout Prevention and Recovery Program

Member Crossland made a motion to adopt Policy 10021 Dropout Prevention and Recovery Program. Member Peters seconded the motion. Motion passed unanimously.

Public Comment (5:00 PM)

Allyson McGuire-Equity Policy Speaking on behalf of a group of parents. Does not understand why there is a continued delay in not adopting this policy. 65% of respondents are in support of this policy. Why do you still need to listen to the 1/3 when you can listen to the 2/3 in support. What percentage of support is enough to move forward. What kind of school district are we going to be?

Fritz Edelstein-Equity Policy - There are some grammatical issues with the current policy that is posted and he will share those privately. We need to figure out a way that students understand what this means in an equitable system. A policy statement never includes an action plan, action

comes after policy adoption/implementation. Fritz also said there is a need to have some community representation in an action plan.

Jonathan Mount-Equity Policy-Graduate from PCHS. This policy contradicts the notion of treating all students the same. In his viewpoint this is discrimination. He wants to see teachers hired on their qualifications.

Lisa Wall-Equity Policy – She assumes the policy will pass no matter what anyone has to say. Why won't the board answer questions about this policy if it is so great? Students who spoke at a recent forum seem to think that this policy will alleviate issues for students, she doesn't think so. The Safe Schools policy should do this. What is the hidden agenda. She thinks the district is planning for hiring more positions for this policy and that makes her nervous with a potential tax increase.
