### **Program Updates:**

### **Review presentation of Galen College of Nursing proposed ADN Program:**

Representatives from Galen College of Nursing, Ms. Denker and Ms. Green, presented their associate degree of nursing program to the Committee.

ACEN granted provisional approval to submit their application for candidacy of their Draper, UT location.

Galen College of Nursing is seeking the Committee's approval to move forward to start their program.

Students will be enrolled into their ADN program on a quarterly basis.

After a brief discussion, the Committee is in favor of Galen College of Nursing moving forward with their process.

Dr. Takeno motioned to temporarily approve (while ACEN accreditation is pending) the ADN program and qualify their graduates for licensure.

Dr. Winslow seconded the motion.

The vote in favor was unanimous.

#### **LEGISLATIVE UPDATE:**

Current pending bills in the Legislative Session:

##### **H.B. 530 – Nurse Education Program Amendments**

This bill amends definitions, Board of Nursing duties, and requires nursing education programs to meet minimum education standards in order for the education program to qualify graduates of the program for the various nursing licenses.

##### **H.B. 264 – Certified Nursing Aide Requirement for Licensure**

This bill allows a certified nurse aide to obtain experience at a health care facility that is designated by DOPL and allows the certified nurse aide applicant to obtain a letter recommendation from a health care facility administrator.

##### **S.B. 36 – Professional Licensing Amendments**

This bill modifies provisions related to professional licensing.

#### **ENVIRONMENTAL SCAN:**

The NCLEX will roll out a new format of the exam on April 1, 2023.
