**SETTING FORTH POWER RATES FOR THE CITY OF SPRING CITY BY THE  
SPRING CITY COUNCIL**

**WHEREAS**, the City Council of Spring City recognizes the need for an increase in the power base rates to keep the power fund within budget requirements; and

**WHEREAS**, the City Council of Spring City understands that any power rates set by resolution beforehand will be superseded by the new rates, and

**WHEREAS**, the City Council of Spring City does hereby set forth the following power rates: The minimum base rate per service shall be set at \$25.00 for in Spring City Customers and \$30.00 for out-of-town customers. The rates charged to customers for purchase of electrical power to be set forth as follows:

- \$.115 per kilowatt hour (kWh)
- \$4.00 Capacity Charge for usage above 500 kWh and below 800 kWh
- \$4.00 Capacity Charge for usage exceeding 800 kWh
- \$4.00 Capacity Surcharge for Interconnected Distributed Power Generation

**WHEREAS**, the above resolution was introduced in writing, read in full, and pursuant to the motion of **Craig Clark** and seconded by **Paul Penrod** was adopted by the vote as stated below this 1<sup>st</sup> Day of June 2023.

**NOW THEREFORE**, be it ordained by the Council of Spring City, in the State of Utah, as follows:

**SETTING FORTH SEWER RATES FOR THE CITY OF SPRING CITY BY THE  
SPRING CITY COUNCIL**

**WHEREAS**, the City Council of Spring City recognizes the need for an increase in the sewer base rates to keep the sewer fund within budget requirements and make Spring City eligible for funding for sewer system enhancement projects, and

**WHEREAS**, the City Council of Spring City understands that any sewer rates set by resolution beforehand will be superseded by the new rates, and

**WHEREAS**, the City Council of Spring City does hereby recognize that Spring City Municipal Code allows for charges, fees, and assessments to be administered to premises to which a connection is supplied or service made available, within three hundred (300) feet, and

**WHEREAS**, the City Council of Spring City does hereby set forth the following sewer rates for all customers within three hundred (300) feet of the public sewer line as follows: The minimum base rate per service shall be set at \$47.00 for in Spring City Customers and \$52.00 for out-of-town customers.

**WHEREAS**, the above resolution was introduced in writing, read in full, and pursuant to the motion of **Nancy Allred** and seconded by **Courtney Syme** was adopted by the vote as stated below this 1<sup>st</sup> Day of June 2023.

**NOW THEREFORE**, be it ordained by the Council of Spring City, in the State of Utah, as follows:

**SETTING FORTH WATER RATES FOR THE CITY OF SPRING CITY BY THE  
SPRING CITY COUNCIL**

**WHEREAS**, the City Council of Spring City recognizes the need for an increase in the water base rates to keep the water fund within budget requirements and make Spring City eligible for funding on water system enhancement project, and

**WHEREAS**, the City Council of Spring City understands that any water rates set by resolution beforehand will be superseded by the new rates, and

**WHEREAS**, the City Council of Spring City does hereby set forth the following water rates:

- The minimum base rate per service shall be set at \$53.00 for in Spring City Customers and \$58.00 for out-of-town customers with the minimum rate covering the purchase of the first 5,000 gallons.
- Tier 1: Cost per thousand (1,000) gallons from 5,001 to 10,000 gallons use will be \$1.50 (one dollar and fifty cents) for in Spring City Customers and \$2.25 (two dollars and twenty-five cents) for out-of-town Customers.
- Tier 2: Cost per thousand (1,000) gallons from 10,001 to 15,000 gallons use will be \$2.00 (two dollars) for in Spring City Customers and \$3.00 (three dollars) for out-of-town Customers.
- Tier 3: Cost per thousand (1,000) gallons from 15,001 to 20,000 gallons use will be \$2.50 (two dollars and fifty cents) for in Spring City Customers and \$3.75 (three dollars and seventy-five cents) for out-of-town Customers.
- Tier 4: Cost per thousand (1,000) gallons from 20,001 gallons and over will be \$3.50 (three dollars and fifty cents) for in Spring City Customers and \$5.25 (five dollars and twenty-five cents) for out-of-town Customers, and

**WHEREAS**, the City Council of Spring City does hereby set forth the following water rates for those who have water leaks that are undetected and have them repaired within a month's time, the City Council of Spring City does hereby set for the following water rates for leaks:

- The rate for the minimum shall remain as stated above for the first 5,000 gallons.
- The cost per thousand from 6,000 gallons and over will be \$1.50 and shall be approved by the Mayor or Council so as not to make a financial burden on the customer. This overage amount can be paid on time each month for the length of 3 months if the leak is fixed within the month.

**WHEREAS**, the City Council of Spring City does hereby set forth the following water rates for those who have their services reconnected after a disconnect

- Re-connection fees will be set at the rate of Sixty Dollars (\$60.00).

**WHEREAS**, the above resolution was introduced in writing, read in full, and pursuant to the motion of **Nancy Allred** and seconded by **Tim Clark** was adopted by the vote as stated below this 1<sup>st</sup> Day of June 2023.

**NOW THEREFORE**, be it ordained by the Council of Spring City, in the State of Utah, as follows:

**SECTION 1: ADOPTION** 2023-04 Power rates of the Spring City Municipal Resolution is hereby *added* as follows:



**A RESOLUTION ADOPTING THE FISCAL YEAR 2023-2024 BUDGET OF FUNDS

**WHEREAS**, Utah Code Annotated (UCA) §10-6-118 requires each municipality to adopt, by resolution or ordinance, a budget for the ensuing fiscal period for each fund for which a budget is required; and,

**WHEREAS**, in accordance with UCA §10-6-114, a Public Hearing was properly noticed on May 115, 2023, and held on June 1, 2023, concerning the proposed tentative budget and comments received relating thereto; and,


